CITY RESOLUTION NO. 227-2018

**RESOLUTION DECLARING TUGUEGARAO CITY
 UNDER A STATE OF CALAMITY DUE TO TYPHOON OMPONG**

WHEREAS, Section 458 (1) (iv) of the Local Government Code of 1991 provides that the Sangguniang Panlungsod shall *“adopt measures to protect the inhabitants of the city from the harmful effects of man-made or natural disasters and calamities, and to provide relief services and assistance for victims during and in the aftermath of said disasters or calamities and in their return to productive livelihood following said events”*;

WHEREAS, Tuguegarao City was placed under signal no. 4 by the Philippine Atmospheric Geological and Astronomical Services Administration (PAGASA) on September 15, 2018 due to typhoon “Ompong”;

WHEREAS, Tuguegarao City was devastated by Typhoon “Ompong”, displacing and affecting residents and causing total damage to agricultural crops particularly to corn, rice and high value crops and livestock as well as causing heavy damage to government infrastructures, school buildings, private homes and buildings and causing total damage to properties;

WHEREAS, the City Disaster Risk Reduction and Management Council (CDRRMC) had an emergency meeting on September 15, 2018 and passed Council Resolution No. 05-2018 – *A Resolution Recommending Tuguegarao City Under a State of Calamity Due to Damages Caused by Typhoon Ompong (Mangkhut)*;

WHEREAS, the City Mayor, Hon. Jefferson P. Soriano, requested for the holding of a special session on September 15, 2018 for the declaration of Tuguegarao City under a state of Calamity due to typhoon “Ompong”;

WHEREAS, the City Social Welfare and Development Officer, City Veterinarian, City In Charge of Infrastructure, Chief of the City Disaster Risk Reduction and Management Office and the City Agriculturist have reported on the extent of damage of affected households, livestock, government buildings and agricultural crops during the said special session.

NOW, THEREFORE, RESOLVED, as it is hereby **RESOLVED**, to declare Tuguegarao City under a State of Calamity due to typhoon "Ompong."

RESOLVED FURTHER, that necessary measures be undertaken to facilitate the rescue, recovery, relief, rehabilitation and return to productive livelihood of the affected citizenry of Tuguegarao City.

On joint motion, **CITY RESOLUTION NO. 223-2018** was **APPROVED** under suspended rules.



Council Resolution No. 05, series of 2018

RESOLUTION RECOMMENDING THE TUGUEGARAO CITY UNDER A STATE OF CALAMITY DUE TO DAMAGES CAUSED BY TYPHOON "OMPONG (MANGKHUT)

WHEREAS, Republic Act 10121 otherwise known as "Philippine Disaster Risk Reduction and Management Act of 2010", to uplift the morale of disaster victims and hasten the return of normalcy in disaster-stricken areas, the entire resources of both national and local government should be mobilized and utilized to the maximum extent. Relief and rehabilitation efforts should likewise be facilitated with the full participation of all concerned sectors of society;

WHEREAS, under Section 1(m), Rule 2 of IRR of R.A No. 10121, the provision of emergency assistance during or immediately after a disaster in order to save lives, reduce health impacts, ensure public safety and meet the basic subsistence needs of the people affected. Disaster response is predominantly focused on immediate and short term needs and sometimes called "disaster relief";

WHEREAS, disaster relief provides a maximum care, assistance and services to individuals and families affected by disaster, implement emergency rehabilitation projects to lessen the impact of disaster, and facilitate resumption of normal social and economic activities;

WHEREAS, Tuguegarao City was devastated by Typhoon "Ompong", displacing and affecting residents and causing total damage to agricultural crops particularly to our corn, rice and high value crops and livestock as well as causing heavy damage to government infrastructures, school buildings, private homes and buildings and causing total damage to our properties;

WHEREAS, due to the paramount importance of ensuring and preserving the safety of the city's constituency's life, limb and property before, during and after any disaster or calamity, and based on the damage assessment and evaluation of the CDRRM Council, there is an urgent need to recommend the declaration of Tuguegarao City under a state of calamity together with the appropriate disaster mitigation measures without prejudice to any City Ordinance that the 7th City Council may promulgate pursuant to R.A. No. 10121;

WHEREFORE, in view of the foregoing considerations, the CDRRMC acting as a collegial body, in quorum, **RESOLVES** to **APPROVE** the resolution recommending the Tuguegarao City under a state of calamity.


On the joint motion of the members present in an emergency meeting, this CDRRMC RESOLUTION is hereby **APPROVED**.




