RESOLUTION APPROVING THE REPROGRAMMING OF THE CONTINUING APPROPRIATION UNDER THE CAPITAL OUTLAY OF THE OFFICE OF THE MAYOR UNDER FURNITURE AND FIXTURES AND OFFICE EQUIPMENT IN THE AMOUNT OF EIGHT HUNDRED THIRTY THOUSAND PESOS (P830,000.00) TO CONFORM WITH THE NEW PROGRAMS OF WORK

WHEREAS, City Ordinance No. 10-2016 titled "*An Ordinance Authorizing the Realignment of the Continuing Appropriation under the Capital Outlay of the Office of the Mayor; Supplemental Budget No. 01-2005 in the Amount of Eight Hundred Thirty Thousand Pesos (P830,000.00) for the Improvement of the SPA Building, Cagayan National High School (CNHS) to Furniture and Fixtures and Office Equipment*" was enacted by the Seventh City Council;


