WHEREAS, **Justice Ramon Paul Hernando** has been an Associate Justice of the Court of Appeals since February 16, 2010, where he was distinguished for his speedy disposition of cases;

WHEREAS, prior to the Court of Appeals, **Justice Ramon Paul Hernando** served as Presiding Judge of the Regional Trial Court in San Pablo, Laguna and Presiding Judge at the Quezon City's Regional Trial Court Branch 93 and also served as state prosecutor with the Department of Justice for five (5) years;

WHEREAS, Justice Ramon Paul Hernando hails from Tuguegarao City and finished his secondary education at Saint Louis College of Tuguegarao, now University of Saint Louis Tuguegarao in 1982;

WHEREAS, the appointment of Supreme Court Associate Justice Ramon Paul Hernando brought pride, respect and honor to the people of Tuguegarao.

NOW, THEREFORE, RESOLVE, as it is hereby **RESOLVED,** that the people of Tuguegarao commend **Honorable Ramon Paul Hernando** for his appointment as Associate Justice of the Supreme Court.
