CITY RESOLUTION NO. 241-2018

**A RESOLUTION GRANTING AUTHORITY TO THE CITY MAYOR,
 HON. ATTY. JEFFERSON P. SORIANO, TO SIGN FOR AND ON BEHALF OF THE
 TUGUEGARAO CITY GOVERNMENT THE MEMORANDUM OF AGREEMENT (MOA)
 WITH THE PROVINCIAL GOVERNMENT OF DAVAO DEL NORTE**

WHEREAS, Section 33 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991 allows local government units, upon approval by the sanggunian concerned contribute funds and other kinds of property under such terms and conditions as may be agreed upon by the participating local units through a Memorandum of Agreement;

WHEREAS, pursuant to the above, the Provincial Government of Davao Del Norte agreed to transfer and augment the amount of Five Hundred Thousand Pesos (P500,000.00) in favor of the Tuguegarao City Government to be used for the rehabilitation and implementation of the disaster related activities to the affected areas of Tuguegarao City as an aftermath of typhoon Ompong;

WHEREAS, the City Mayor, Hon. Atty. Jefferson P. Soriano has endorsed the Memorandum of Agreement (MOA) between the Tuguegarao City Government and the Provincial Government of Davao Del Norte for the said funds and to grant him authority to sign for and on behalf of the Tuguegarao City Government the said MOA;

WHEREAS, after a discussion and deliberation on the matter during their 103rd Regular Session, the Seventh City Council deemed it urgent, necessary and proper to approve the herein request being beneficial to the constituents of the City.



On joint motion, **CITY RESOLUTION NO. 241-2018** was **APPROVED** under suspended rules.


