## CITY RESOLUTION NO. 248-2018

### A RESOLUTION APPROVING THE ACCREDITATION OF SENIOR CITIZENS (FWLSBA) INTERNATIONAL, INC. REGION 02 CHAPTER AS A CIVIL SOCIETY ORGANIZATION BASED IN TUGUEGARAO CITY PURSUANT TO DILG MC NO. 2016-97

WHEREAS, the Department of the Interior and Local Government (DILG) issued Memorandum Circular No. 2016-97 "Accreditation of Civil Society Organizations and Selection of Representatives to the Local Special Bodies" dated July 19, 2016;

WHEREAS, the said Memorandum of Agreement reiterates the provisions of the Local Government Code relative to the accreditation of civil society organizations and in the selection of representatives to the local special bodies to strengthen their participation in local governance and development processes;

WHEREAS, the Sangguniang Panlungsod of Tuguegarao City recognizes the vital role of Civil Society Organizations (CSOs) which include non-stock and non-profit associations, non-governmental organizations, people's organizations, civil organizations, cooperatives, social movements and professional and business groups in nation building and their collective efforts towards progress;

WHEREAS, the Sangguniang Panlungsod of Tuguegarao City through the Committee on Rules, Laws and Ethics has reviewed and recommended the approval of the application for accreditation of Senior Citizens (FWLSBA) International, Inc. Region 02 Chapter having complied with the administrative and documentary requirements;

WHEREAS, the accreditation shall be valid upon the approval of this resolution up to June 30, 2019;
