CITY RESOLUTION NO. 253-2018

A RESOLUTION GRANTING ONE (1) HECTARE FREE TRACTOR SERVICES FROM OCTOBER 2018 TO JANUARY 31, 2019 FOR ALL FARMERS OF TUGUEGARAO CITY AFFECTED BY SUPER TYPHOON OMPONG

WHEREAS, Super Typhoon Ompong struck Tuguegarao City on September 15, 2018 which resulted to expansive damages to agricultural crops in the city;

WHEREAS, the City Agricultural and Fishery Council (CAFC) during its regular meeting last September 26, 2018 passed CAFC Resolution No. 02-2018 titled "Resolution Requesting for One (1) Hectare Free Tractor Services for all Farmers of Tuguegarao City Affected by Super Typhoon "Ompong" last September 15, 2018;"

WHEREAS, as required by the said CAFC Resolution, a total of 2,390 hectares of corn was damaged affecting the livelihood of farmers;

WHEREAS, the implementation period for free tractor services is only for one (1) cropping period during the dry season from October 2018 to January 31, 2019;

WHEREAS, the schedule for the use of the tractor as prepared and submitted by Servando Gumabay, CAFC Chairman, and approved by Dr. Evangeline P. Calubaquib, City Agriculturist, forms part of this Resolution;

WHEREAS, the free tractor services are exclusively for one (1) hectare only per farmer and in excess of one (1) hectare as certified by the Office of the City Agriculturist shall be shouldered by the farmer and shall be paid in cash at the City Treasurer's Office;

WHEREAS, the Masterlist of Farmers affected by Typhoon Ompong and the corresponding schedules for free tractor services as agreed upon by the CAFC Officers and the City Agriculture Office were submitted;

WHEREAS, the Committee on Agriculture and Food together with the Committee on Rules, Laws and Ethics and Committee on Ways and Means met on October 25, 2018 to deliberate on the subject referral titled "*Indorsement of the City Mayor, Hon. Atty. Jefferson P. Soriano, on City Agricultural and Fishery Council (CAFC) Resolution No. 02-2018 titled "Resolution Requesting for One (1) Hectare Free Tractor Services for all farmers of Tuguegarao City Affected by Super Typhoon Ompong last September 15, 2018;"*"


WHEREAS, the joint committees find the subject indorsement to be meritorious and beneficial to the constituents of Tuguegarao City, hence, favorably recommend the passage of a resolution approving the aforesaid request.

NOW, THEREFORE, RESOLVE, as it is hereby **RESOLVED**, to grant one (1) hectare free tractor services from October 2018 to January 31, 2019 for all farmers of Tuguegarao City affected by Super Typhoon Ompong.

On motion of Hon. Winnoco R. Abraham, duly seconded by Hon. Jude T. Bayona and without any objection, **CITY RESOLUTION NO. 258-2018** was **APPROVED** under suspended rules.
