**CITY RESOLUTION NO. 268-2018**

**RESOLUTION APPROVING THE MEMORANDUM OF AGREEMENT (MOA)  
BETWEEN THE LOCAL GOVERNMENT UNIT OF TUGUEGARAO AND THE  
TUGUEGARAO TOBACCO PRODUCERS COOPERATIVE FOR THE GRANT OF  
FINANCIAL ASSISTANCE AND GRANTING AUTHORITY TO THE INCUMBENT  
CITY MAYOR, HON. ATTY. JEFFERSON P. SORIANO, TO SIGN THE SAID MOA  
FOR AND ON BEHALF OF THE CITY GOVERNMENT**

**WHEREAS**, pursuant to Section 8, Republic Act No. 8240 titled "*An Act Amending Sections 138, 139, 140 and 142 of the National Internal Revenue Code, as Amended, and for Other Purposes*", the cooperative has the objective of uplifting the economic way of life of its tobacco farmer-members by providing alternative livelihood program and additional source of income other than farming. The cooperative also aims to extend financial assistance to its members to defray their expenses in farming and in augmenting their capital for farm input;

**WHEREAS**, the Tuguegarao City Government is willing to support the projects and programs of the cooperative in accordance with the approved Work and Financial Plan;

**WHEREAS**, the total amount of Two Million Seven Hundred Twenty Four Thousand Six Hundred Eight Pesos (P2,724,608.00) has been released by the Department of Budget and Management to the City Government of Tuguegarao as its share pursuant to R.A. 8240 as amended by R.A. 10351 and Local Budget Memorandum No. 72 dated March 8, 2016 on the Guidelines for the Release and Utilization of the Shares of LGUs from the Tobacco Excise Tax particularly Section 4.2 (4.2 and 4.2.3) and Local Budget Memorandum No. 72 dated March 8, 2016;

**WHEREAS**, the Joint Committees on Rules, Laws and Ethics and Committee on Agriculture and Food met on November 19, 2018 to deliberate on the subject referral titled “*Indorsement of the Acting City Mayor, Hon. Bienvenido C. De Guzman II, requesting for an authority for the City Mayor to sign for and on behalf of the Tuguegarao City Government the Memorandum of Agreement with the Tuguegarao Tobacco Producers Cooperative, certified urgent*”;


**WHEREAS**, the joint committees find the terms and conditions on the Memorandum of Agreement to be in order and beneficial to the constituents of Tuguegarao City particularly to the members of the Tuguegarao Tobacco Producers Cooperative.

**NOW, THEREFORE, RESOLVE**, as it is hereby **RESOLVED**, to approve the request for the passage of a Resolution Approving the Memorandum of Agreement (MOA) between the Local Government Unit of Tuguegarao and the Tuguegarao Tobacco Producers Cooperative for the grant of financial assistance and to grant authority to the City Mayor, Hon. Atty. Jefferson P. Soriano, to sign the said MOA for and on behalf of the Tuguegarao City Government.




