**CITY RESOLUTION NO. 271-2018**

**RESOLUTION DIRECTING THE BUSINESS PERMITS AND LICENSING OFFICE (BPLO) TO PROCEED WITH THE ISSUANCE OF MAYOR'S PERMIT FOR THE RETAIL SALE OF FIRECRACKERS PURSUANT TO CITY ORDINANCE NO. 41-2017 TITLED "ORDINANCE REGULATING THE SALE, DISTRIBUTION, POSSESSION AND USE OF FIRECRACKERS, PYROTECHNIC DEVICES AND OTHER SIMILAR EXPLOSIVES WITHIN THE TERRITORIAL JURISDICTION OF TUGUEGARAO CITY"**

**WHEREAS**, the OIC-City Mayor, Hon. Bienvenido C. De Guzman II, indorsed to the Seventh City Council the Memorandum of P/Supt. Andres C. Baccay, Head of the Business Permits and Licensing Office (BPLO), regarding the request of the Tuguegarao City Firecrackers Retailers Association for the early issuance of Mayor's Permit for the retail sale of firecrackers within the vicinity of Macapagal Boulevard, Tuguegarao City;

**WHEREAS**, the said indorsement was included in the agenda of the Seventh City Council during the 109<sup>th</sup> Regular Session held on December 3, 2018;

**WHEREAS**, the Seventh City Council deliberated and discussed thoroughly and extensively the request during the said session;

**WHEREAS**, to be consistent with their action last year on the request for the transfer of the vending area to the vicinity of Macapagal Avenue, the Seventh City Council deemed it proper not to grant the request of the transfer pursuant to City Ordinance No. 41-2017.

**NOW, THEREFORE, RESOLVE**, it is hereby **RESOLVED**, to direct the Business Permits and Licensing Office (BPLO) to proceed with the issuance of Mayor's Permit for the retail sale of firecrackers




