CITY RESOLUTION NO. 277-2018

RESOLUTION APPROVING THE MEMORANDUM OF AGREEMENT WITH THE PROVINCIAL GOVERNMENT OF CAGAYAN AND GRANTING AUTHORITY TO THE CITY MAYOR, HON. ATTY. JEFFERSON P. SORIANO, TO SIGN FOR AND ON BEHALF OF THE TUGUEGARAO CITY GOVERNMENT THE SAID MEMORANDUM OF AGREEMENT FOR THE CONCRETING OF DUPAYA STREET, LEONARDA, TUGUEGARAO CITY, CAGAYAN AMOUNTING TO ONE MILLION PESOS (P1,000,000.00)

WHEREAS, Section 333 of Republic Act 7160, otherwise known as the Local Government Code of 191, provides that Local Government Units may group themselves, consolidate or coordinate their efforts, services and resources for purposes commonly beneficial to them;

WHEREAS, the Provincial Government of Cagayan through its CY 2016 budget has identified Tuguegarao City as one of the recipients of the financial assistance amounting to One Million Pesos (P1,000,000.00) for the concreting of Dupaya Street, Leonarda, Tuguegarao City;

WHEREAS, the City Mayor, Hon. Atty. Jefferson P. Soriano, requested from the Seventh City Council through his letter dated November 26, 2018 for an authority to sign the Memorandum of Agreement with the Provincial Government of Cagayan;

WHEREAS, the joint Committees on Infrastructure and Public Utilities and Committee on Rules, Laws and Ethics during the committee meeting held for the said purpose found the Memorandum of Agreement to be in order, meritorious and beneficial to the constituents of Barangay Leonarda, Tuguegarao City.




NOW, THEREFORE, RESOLVE, as it is hereby **RESOLVED**, to approve the Memorandum of Agreement with the Provincial Government of Cagayan and to grant authority to the City Mayor, Hon. Atty. Jefferson P. Soriano, to sign for and on behalf of the Tuguegarao City Government the said Memorandum of Agreement for the concreting of Dupaya Street, Leonarda, Tuguegarao City, Cagayan amounting to One Million Pesos (P1,000,000.00).

RESOLVED FURTHER, to forward a copy of this Resolution to the Provincial Governor of Cagayan, Hon. Manuel N. Mamba, for information.


