CITY RESOLUTION NO. 319-2018

RESOLUTION APPROVING THE REPROGRAMMING OF THE UNUSED FUND OF P27M EARMARKED FOR PHASES II AND III OF TUGUEGARAO CITY PUBLIC MARKET (DON DOMINGO) FOR ITS DEMOLITION AND THE CONSTRUCTION OF A TEMPORARY ONE FOR THE RELOCATION OF THE STALLHOLDERS FOR ITS CONTINUED OPERATION

WHEREAS, the City Mayor, Hon. Jefferson P. Soriano, has requested for the passage of a city resolution for the reprogramming of the unused fund of P27M earmarked for Phases II and III of Tuguegarao City Public Market (Don Domingo) for its demolition and the construction of a temporary one for the relocation of the stallholders for its continued operation;

WHEREAS, the Tuguegarao City Public Market (Don Domingo) has been severely hit by super typhoons Lawin and Ompong causing damages in its building structures notwithstanding the usual damage or deterioration resulting from its wear and tear and deplorable state of condition;

WHEREAS, the Tuguegarao City Public Market (Don Domingo) is an important facility of the city since it serves as a commercial hub serving a number of residents;

WHEREAS, there is a need for the upgrading (demolition and new construction) of the Tuguegarao City Public Market (Don Domingo) to improve its structures and become a better and more convenient public market with important facilities;

WHEREAS, there is an unused fund of P27M earmarked for Phases II and III of Tuguegarao City Public Market (Don Domingo) as certified by the Head of the Infrastructure Projects Unit, Engr. Francisco V. Lingan, Jr., which shall be reprogrammed for the demolition of the Tuguegarao City Public Market (Don Domingo) and the relocation of the stallholders to ensure the continuity of services the market offers;

WHEREAS, City Resolution No. 318-2018 has been duly passed by this august Body granting authority to the City Mayor, Hon. Jefferson P. Soriano, to demolish and reconstruct the Tuguegarao City

Public Market (Don Domingo) subject to compliance with Commission on Audit (COA) rules and regulations;

WHEREAS, the Local Finance Committee has certified the available appropriation in the amount of P27M appropriated under 20% Development Fund Continuing Appropriation.


NOW, THEREFORE, RESOLVE, as it is hereby **RESOLVED**, to approve the reprogramming of the unused fund of P27M earmarked for Phases II and III of Tuguegarao City Public Market (Don Domingo) for its demolition and construction of a temporary one for the relocation of the stallholders for its continued operation.

RESOLVED FURTHER, that the remaining balance of the P27M shall be used to continue with the main construction of the Tuguegarao City Public Market (Don Domingo).
