**A RESOLUTION APPROVING CDC RESOLUTION NO. 12-2018 TITLED “RESOLUTION ENDORSING TO THE 7<sup>th</sup> TUGUEGARAO CITY COUNCIL THE INCLUSION OF THE UPGRADING/DEMOLITION AND RECONSTRUCTION OF TUGUEGARAO CITY PUBLIC MARKET (DON DOMINGO) IN THE CY 2017-2019 LOCAL DEVELOPMENT INVESTMENT PROGRAM (LDIP) AND CY 2018 ANNUAL INVESTMENT PROGRAM (AIP)”**

**WHEREAS**, the approved Executive-Legislative Agenda (ELA) for CY 2016-2019 included the approval of Credit Financing for the city’s programs, projects and activities (PPAs);

**WHEREAS**, the Executive-Legislative Agenda (ELA) was amended to include the Upgrading/Demolition and Reconstruction of Tuguegarao City Public Market (Don Domingo) by virtue of City Development Council (CDC) Resolution No. 09-2017 dated September 25, 2018 and was adopted and approved by the 7<sup>th</sup> City Council in City Resolution No. 235-2018 dated October 03, 2018;

**NOW, THEREFORE, RESOLVED**, as it is hereby **RESOLVED**, to approve CDC Resolution No. 12-2017 titled “Resolution Endorsing to the 7<sup>th</sup> Tuguegarao City Council the Inclusion of the Upgrading/Demolition and Reconstruction of Tuguegarao City Public Market (Don Domingo) in the CY




2017-2019 Local Development Investment Program (LDIP) and CY 2018 Annual Investment Program AIP”.


On joint motion, **CITY RESOLUTION NO. 321-2018** was **APPROVED** under suspended rules.
