APPROPRIATION ORDINANCE NO. 05-08-2019

**AN ORDINANCE AUTHORIZING SUPPLEMENTAL BUDGET NO. 4
 OF TUGUEGARAO CITY FOR CY 2019**

WHEREAS, Section 458 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, and Article 99 (2)(i) of the Rules and Regulations Implementing the Local Government Code of 1991 provide that the Sangguniang Panlungsod has the power to “approve annual and supplemental budgets of the City Government and appropriate funds for specific programs, projects, services and activities of the city, or for other purposes not contrary to law, in order to promote the general welfare of the city and its inhabitants;”

WHEREAS, the City Mayor, Hon. Atty. Jefferson P. Soriano, has endorsed to the Eighth City Council the request for the enactment of an Appropriation Ordinance authorizing Supplemental Budget No. 4 for CY 2019 in the amount of Eight Million Four Hundred Sixty Thousand Pesos (P8,460,000.00) for the grant of Service Recognition Incentive for FY 2019 as per Budget Circular No. 2019-6 dated December 9, 2019;

WHEREAS, the Local Finance Committee has certified that the amount of Eight Million Four Hundred Sixty Thousand Pesos (P8,460,000.00) is free from any obligation and is available for appropriation;

WHEREAS, Supplemental Budget No. 4 of Tuguegarao City for CY 2019 has fully complied with the budgetary requirements and general limitations as provided by Republic Act No. 7160, otherwise known as the Local Government Code of 1991 and other laws.

NOW, THEREFORE, be it **ORDAINED** by the Eighth City Council in session assembled, to enact:

SECTION 1. AUTHORIZATION. Supplemental Budget No. 4 of Tuguegarao City for CY 2019 with a total appropriation of Eight Million Four Hundred Sixty Thousand Pesos (P8,460,000.00) is authorized for

the grant of Service Recognition Incentive for FY 2019 pursuant to Administrative Order No. 19 of the President, subject to the guidelines set forth under Department of Budget and Management (DBM) Budget Circular No. 2019-6 dated December 9, 2019.

SECTION 2. SOURCE OF APPROPRIATION. The Appropriation shall be sourced out from the Savings from Personal Services Appropriation (Terminal Leave Pay) of the following:

SECTION 6. EFFECTIVITY. This Appropriation Ordinance shall take effect immediately upon its approval.




