APPROPRIATION ORDINANCE NO. 01-2019

AN ORDINANCE AUTHORIZING SUPPLEMENTAL BUDGET NO. 01 OF TUGUEGARAO CITY FOR CY 2019

WHEREAS, Section 458 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, and Article 99 (2)(i) of the Rules and Regulations Implementing the Local Government Code of 1991 provide that the Sangguniang Panlungsod has the power to "approve annual and supplemental budgets of the City Government and appropriate funds for specific programs, projects, services and activities of the city, or for other purposes not contrary to law, in order to promote the general welfare of the city and its inhabitants;"

WHEREAS, City Development Council (CDC) Resolution No. 01, Series of 2019 titled "Resolution Endorsing to the Seventh City Council the approval of the Supplemental Annual Investment Program CY 2019 for Supplemental Budget No. 01 CY 2019" was approved through City Resolution No. 027-2019 by the Seventh City Council during its 118th Regular Session held on February 19, 2019;

WHEREAS, the City Mayor, Hon. Atty. Jefferson P. Soriano, has endorsed to the Seventh City Council the request for the enactment of an Appropriation Ordinance authorizing Supplemental Budget No. 01 CY 2019 in the amount of One Hunched Fourteen Million Six Thousand Three Hundred Eighty-Four Pesos (Pl 14,006,384.00) to fund the Priority Programs, Projects and Activities of the City as contained in CDC Resolution No. 01, Series of 2019;

WHEREAS, the Local Finance Committee has certified that the amount of One Hundred Fourteen Million Six Thousand Three Hundred Eighty-Four Pesos (Pl 14,006,384.00) is free from any obligation and is available for appropriation;

WHEREAS, all Programs, Projects and Activities funded under proposed Supplemental Budget No. 01 are in confonnity with the approved Supplemental Annual Investment Program as well as the Executive-Legislative Agenda;



WHEREAS, Supplemental Budget No. 01 of Tuguegarao City for CY 2019 has fully complied with the budgetary requirements and general limitations as provided by Republic Act No. 7160, otherwise known as the Local Government Code of 1991 and other laws.

NOW, THEREFORE, be it ORDAINED by the Seventh City Council in session assembled, to enact:

SECTION 1. AUTHORIZATION. Supplemental Budget No. 01 of Tuguegarao City for CY 2019 with a total appropriation of One Hundred Fourteen Million Six Thousand Three Hundred Eighty-Four Pesos (Pl 14,006,384.00) is authorized to finance the Priority Programs, Projects and Activities of the City.

SECTION 2. SOURCE OF FUNDS. The Appropriation shall be sourced out from the Retained Earnings of CY 2018 in the amount of One Hundred Fourteen Million Six Thousand Three Hundred Eighty-Four Pesos (Pl 14,006,384.00).

SECTION 3. USE OF FUNDS. The amount of One Hundred Fourteen Million Six Thousand Three Hundred Eighty-Four Pesos (Pl 14,006,384.00) is hereby appropriated for Supplemental Budget No. 01 of Tuguegarao City for CY 2019 as follows:
