CITY ORDINANCE NO. 03-2019

**AN ORDINANCE AMENDING SECTIONS 2 AND 7 OF CITY ORDINANCE NO. 12-2016
TITLED "ORDINANCE INSTITUTIONALIZING THE CONDUCT OF BARANGAY
PEOPLE'S DAY WITHIN THE TERRITORIAL JURISDICTION OF TUGUEGARAO CITY AND
PROVIDING FUNDS THEREOF"**

WHEREAS, under Chapter 2, Section 17 of the Local Government Code (LGC), it is the obligation of the Local Government Unit (LGU) to provide basic services to the barangays;

WHEREAS, the conduct of the Barangay People's Day in the Barangays will give opportunity to its constituents to avail the services of the Tuguegarao City Government;

WHEREAS, the conduct of the Barangay People's Day will bring the City Government closer to the people and will ensure the participation of the people in local governance;

WHEREAS, with the clamor of the people, there is a need to conduct the Barangay People's Day frequent than the usual once a week for all barangays to be accorded the services of the Tuguegarao City Government;

NOW, THEREFORE, be it **ORDAINED** by the Sangguniang Panlungsod of Tuguegarao City in session assembled, to enact the following:

Section 1. Section 2 of Ordinance No. 12-2016 is hereby amended to be read as follows:

"The Barangay People's Day shall be at least once a week except during regular holidays and non-working holidays and shall be in any day of the week to be determined by the City Mayor."




Section 2. Section 7 of Ordinance No. 12-2016 is hereby amended to be read as follows:

“National agencies, line agencies, Government Owned and Controlled Corporations (GOCCs), Non-Governmental Organizations (NGOs) and private organizations are also enjoined to participate in the Barangay People’s Day.”

On joint motion, **CITY ORDINANCE NO. 03-2019** was **APPROVED** under suspended rules.


