CITY ORDINANCE NO. 038-08-2019

**AN ORDINANCE AMENDING ORDINANCE NO. 036-08-2019 TITLED
 "AN ORDINANCE DECLARING THE TEMPORARY CLOSURE OF THE
 RIGHT SIDE OF TUGUEGARAO CITY PUBLIC MARKET (DON DOMINGO) ROAD
 AS A RELOCATION SITE OF ALL SIDEWALK VENDORS IN THE CITY"**

WHEREAS, in line with the priority projects of the present administration for infrastructure, particularly the construction of the New Don Domingo Public Market which is now ongoing, there is an urgent need to relocate the vendors who were displaced;

WHEREAS, a number of sidewalk/ambulant vendors were not accommodated in the existing relocation area;

WHEREAS, the City Mayor, Hon. Atty. Jefferson P. Soriano, requested the Eighth City Council to allow market vendors to use both shoulders of Tuguegarao City Public Market (Don Domingo) Road;

WHEREAS, by virtue of Committee Report No. 164-2019, the Eighth City Council during their 13th Regular Session deemed it proper, necessary and beneficial to grant the said request but instead of the original request for a resolution, the committees recommended for the enactment of an ordinance amending City Ordinance No. 036-2019 to give more teeth to its implementation.

NOW, THEREFORE, be it **ORDAINED** by the Eighth City Council in session assembled to amend City Ordinance No. 036-08-2019, as follows:

Section 1. SCOPE AND LIMITATIONS. This Ordinance shall allow the market vendors who were displaced to use both shoulders of Tuguegarao City Public Market (Don Domingo) road.

Section 2. IMPLEMENTING RULES. The implementation of this ordinance shall be subject to the following rules:




1. The stalls to be erected at both shoulders of the road shall be at least 1.5 meters length by .80 meters width.
2. All legitimate stall owners in the old Tuguegarao City Public Market (Don Domingo) should be relocated in the identified relocation area.
3. All sidewalk vendors including ambulant vendors should stay on both shoulders of the Tuguegarao City Public Market (Don Domingo) Road.
4. There shall be no parking on both sides of the Tuguegarao City Public Market (Don Domingo) Road.
5. No sidewalk/ambulant vendors shall occupy the frontal part of business establishments.
6. Determination/identification of stalls by legitimate stall owners shall be done through drawing of lots.

Section 3. IMPLEMENTATION. This ordinance shall be implemented by the Office of the City Chief of Police in coordination with the Tuguegarao City Traffic Management Group. Further, the City Chief of Police in coordination with the Public Order and Safety Unit (POSU) shall take charge of the traffic and provide adequate loading, unloading and parking areas as well as appropriate access in cases of emergency.


SECTION 4. EFFECTIVITY CLAUSE. This Ordinance shall take effect immediately upon approval.
