**CITY ORDINANCE NO. 43-08-2019**

**AN ORDINANCE GRANTING AUTHORITY TO THE CITY MAYOR, HON. ATTY. JEFFERSON P. SORIANO, TO EXPAND THE ONGOING NIGHT MARKET TO INCLUDE CORNER BONIFACIO TO CORNER BURGOS STREET, CORNER BURGOS TO CORNER DEL ROSARIO STREET, CORNER DEL ROSARIO TO CORNER TAFT STREET, CORNER TAFT STREET TO CORNER MAGALLANES STREET, CORNER MAGALLANES TO MABINI STREET AND TO CLOSE THE SAID STREETS FOR THE SAID PURPOSE**

**WHEREAS**, the Eighth City Council approved City Ordinance No. 039-08-2019 titled “*An Ordinance Authorizing the Conduct of Night Market on an Experimental Basis Along Gomez Street (Corner Bonifacio to Corner Taft Street) for a Period of Six (6) Months from October 15, 2019 to April 15, 2020 from 6:00 P.M. To 1:00 A.M.*” on its 14<sup>th</sup> Regular Session held on October 07, 2019;

**WHEREAS**, likewise, City Ordinance No. 040-08-2019 titled “*City Ordinance Authorizing the Temporary Closure from Vehicular Traffic for the Conduct of Night Market of Portions of Gomez Street (Corner Bonifacio to Corner Taft Street) for a Period of Six (6) Months from October 15, 2019 to April 15, 2020 from 6:00 P.M. to 1:00 A.M.*” was also approved by the Eighth City Council on its 14<sup>th</sup> Regular Session held on October 07, 2019;

**WHEREAS**, the City Mayor, Hon. Atty. Jefferson P. Soriano, has requested from the Eighth City Council for an authority to expand the ongoing Night Market activity (presently along Gomez Street, from Corner Bonifacio Street to Del Rosario Street) to the remaining western portion of Gomez, particularly from corner Del Rosario Street to Mabini Street;

**WHEREAS**, the expansion is necessary considering the persistent demand from local business community.

**NOW, THEREFORE**, be it **ORDAINED**, by the Eighth City Council in session assembled, to enact:

**SECTION 1. TITLE.** This Ordinance shall be known as “*AN ORDINANCE GRANTING AUTHORITY TO THE CITY MAYOR, HON. ATTY. JEFFERSON P. SORIANO, TO EXPAND THE ONGOING NIGHT MARKET TO INCLUDE CORNER BONIFACIO TO CORNER BURGOS STREET, CORNER BURGOS TO CORNER DEL ROSARIO STREET, CORNER DEL ROSARIO TO CORNER TAFT STREET, CORNER TAFT TO CORNER MAGALLANES STREET, CORNER MAGALLANES TO MABINI STREET AND TO CLOSE THE SAID STREETS FOR THE SAID PURPOSE.*”

**SECTION 2. SCOPE AND LIMITATION.** This Ordinance shall cover the expansion of the ongoing Night Market to include Corner Bonifacio to Corner Burgos Street, Corner Burgos to Corner Del Rosario Street, Corner Del Rosario to Corner Taft Street, Corner Taft to Corner Magallanes Street, Corner Magallanes to Mabini Street and the granting of authority to the City Mayor, Hon. Atty. Jefferson P. Soriano, for the closure of the said streets.


**Section 3. COLLECTION OF FEES.** A fee in the amount of Thirty Pesos (P30.00) per stall per night shall be charged from each vendor who shall occupy the additional streets. The City Treasurer is hereby authorized to collect the said fee which shall accrue to the General Fund.

**Section 4. IMPLEMENTING RULES AND REGULATIONS.** The City Mayor shall include the additional streets for the ongoing Night Market in the Implementing Rules and Regulations (IRR) stated in City Ordinance No. 39-08-2019.


**Section 5. EFFECTIVITY.** This Ordinance shall take effect immediately upon approval.
