CITY ORDINANCE NO. 45-08-2019

**AN ORDINANCE REGULATING THE PASSAGE OF TRUCKS ALONG DIVERSION ROAD
 FROM JUNCTION TANZA TO SHELL BUNTUN DURING PEAK HOURS
 ON AN EXPERIMENTAL PERIOD FOR NINETY (90) DAYS
 FROM NOVEMBER 11, 2019 TO FEBRUARY 10, 2020**

WHEREAS, Section 16 on General Welfare of Republic Act No. 7160, otherwise known as An Act Providing for a Local Government Code of 1991, states that “*Every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare*”;

WHEREAS, Diversion Road is one of the busiest roads in Tuguegarao City being an alternate route which directly links Tanza/Balzain/Carig to Buntun/Luna passing by some barangays such as San Gabriel, Pallua Sur, Pallua Norte and Caritan;

WHEREAS, traffic is congested and is almost at a stand-still at the whole stretch of Diversion Road during peak hours in the morning (from 7:00 AM to 9:00 AM) and in the afternoon (from 4:00 PM to 6:00 PM) because of the volume of vehicles passing through it;

WHEREAS, in order to ease traffic congestion, there is a need to regulate the passage of trucks along Diversion Road during peak hours during certain hours of the day.

NOW, THEREFORE, premises considered, be it **ORDAINED** by the Sangguniang Panlungsod in session duly assembled, to enact the following:

SECTION 1. TITLE. This Ordinance shall be known as “*An Ordinance Regulating the Passage of Trucks Along Diversion Road from Junction Tanza to Shell Buntun During Peak Hours on an Experimental Period for Ninety (90) Days from November 11, 2019 to February 10, 2020.*”


SECTION 2. All cargo, freight and dump trucks with a gross weight of 4.5 tons and above (or 10-wheels and above) are hereby strictly prohibited from passing through Diversion Road from Junction Tanza to Shell Buntun from 7:00 AM to 9:00 AM and from 4:00 PM to 6:00 PM.

SECTION 3. Exempted from this prohibition are trucks carrying perishable food items such as fruits, vegetables, fish and dressed chicken, military trucks, government vehicles, and vehicles carrying goods for calamity victims during calamity periods.


SECTION 4. This Ordinance shall take effect after ten (10) days of posting of a NOTICE at both ends of the Junction Tanza and Shell Buntun.
