CITY ORDINANCE NO. 23-2019

CITY ORDINANCE CREATING THE POSITION OF ONE (1) SUPERVISING TOURISM OPERATIONS OFFICER (SG 22) AND ONE (1) TOURISM OPERATIONS OFFICER II (SG 15) UNDER THE OFFICE OF THE CITY MAYOR AND PROVIDING FUNDS THEREFOR

WHEREAS, Section 76 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, empowers LGUs to design and implement their own organizational structure and staffing pattern that will efficiently address their respective development plans, programs, objectives and priorities;

WHEREAS, the creation of the new positions will augment manpower in the City Tourism Office and improve the delivery of basic services particularly those which have to do with the programs and projects which the City Mayor is empowered to implement and the Sanggunian is empowered to provide for under the Local Government Code of 1991;

WHEREAS, in the exigency of service and in order to promote efficiency and an effective personnel force, there is a need to create new positions for the local government unit of Tuguegarao City and provide funds therefor.

NOW, THEREFORE, be it **ORDAINED** by the 7th City Council in session assembled to enact:

SECTION 1. TITLE. This Ordinance shall be known as "*City Ordinance Creating the Position of Supervising Tourism Operations Officer and Tourism Operations Officer II and Providing Funds Therefor.*"

SECTION 2. CREATION OF NEW POSITIONS. There is hereby created the position of Supervising Tourism Operations Officer (SG 22) and Tourism Operations Officer II (SG 15).


SECTION 3. FUNDING FOR THE NEW POSITIONS. The corresponding fund for the salary and other emoluments and benefits for the Supervising Tourism Operations Officer and Tourism Operations Officer II shall be provided in the next supplemental budget of Tuguegarao City and in its succeeding annual budgets, subject to availability of funds and Personal Services Limitations.

SECTION 4. QUALIFICATIONS. All matters pertinent to recruitment and placement for the above created positions shall be governed by Civil Service laws, rules and regulations and other related issuances.


SECTION 5. EFFECTIVITY. This City Ordinance shall take effect immediately upon approval.
