## CITY ORDINANCE NO. 33-08-2019

AN ORDINANCE CREATING THE POSITION OF ASSISTANT LEGAL OFFICER (SG 23), ONE (1) ATTORNEY III (SG 21) AND TWO (2) ATTORNEY II (SG 18) UNDER THE CITY LEGAL OFFICE AND PROVIDING FUNDS THEREFOR

WHEREAS, Section 76 of Republic Act 7160, otherwise known as the Local Government Code of 1991, empowers LGUs to design and implement their own organizational structure and staffing pattern that will effectively address their respective development plans, objectives and priorities;

WHEREAS, the creation of new positions will augment manpower in the City Legal Office and improve the delivery of basic services particularly those which have to do with the programs and projects which the City Mayor is empowered to implement and which the Sanggunian is empowered to provide for under the Local Government Code of 1991;

WHEREAS, in the exigency of service and in order to promote efficiency and an effective personnel force, there is a need to create new positions for the local government unit of Tuguegarao City and provide funds therefor.

NOW, THEREFORE, be it ORDAINED by the Eighth City Council in session duly assembled, to enact:

SECTION 1. TITLE. This Ordinance shall be known as "AN ORDINANCE CREATING THE POSITION OF ASSISTANT LEGAL OFFICER (SG 23), ONE (1) ATTORNEY III (SG 21) AND TWO (2) ATTORNEY II (SG 18) UNDER THE CITY LEGAL OFFICE AND PROVIDING FUNDS THEREFOR."

SECTION 2. CREATION OF NEW POSITIONS. There is hereby created the position of Assistant Legal Officer (SG 23), one (1) Attorney III (SG 21) and two (2) Attorney II (SG 18) under the City Legal Office.

#### SECTION 3. FUNDING FOR THE NEW POSITIONS.

Personnel Services Limitations; and,

- Assistant Legal Officer (SG 23) The corresponding fund for the salary and other emoluments and benefits for the said position shall be provided in the ensuing Annual Budget of Tuguegarao City subject, however, to
- b. One (1) Attorney III (SG 21) and two (2) Attorney II (SG 18) Funding for the salaries and other emoluments for the said positions shall be subject to the availability of funds and Personnel Services Limitations.

SECTION 4. QUALIFICATIONS. All matters pertinent to recruitment and placement for the above created positions shall be governed by Civil Service laws, rules and regulations and other related issuances.

SECTION 5. EFFECTIVITY. This Ordinance shall take effect upon its approval.
