AN ORDINANCE CREATING THE POSITION OF ONE (1) ADMINISTRATIVE OFFICER IV (SG 22) UNDER THE OFFICE OF THE CITY MAYOR AND PROVIDING FUNDS THEREFOR



WHEREAS, Section 76 of RA 7160, otherwise known as the Local Government Code of 1991, empowers LGUs to design and implement their own organizational structure and staffing pattern that will effectively address their development plans, objectives and priorities;

WHEREAS, the creation of new positions will augment manpower in the City Mayor's Office and improve the delivery of basic services particularly those which have to do with the programs and projects which the City Mayor is empowered to implement and which the Sanggunian is empowered to provide for under the Local Government Code of 1991;

WHEREAS, in the exigency of service and in order to promote efficiency and an effective personnel force, there is a need to create a new position for the local government unit of Tuguegarao City and provide funds therefor.

NOW, **THEREFORE**, be it **ORDAINED**, by the Eighth City Council of Tuguegarao in session duly assembled, to enact:



Section 1. Title. This Ordinance shall be known as "An Ordinance Creating the Position of Administrative Officer IV (SG 22) Under the Office of the City Mayor and Providing Funds Therefor."

Section 2. Creation of New Positions. There is hereby created the position of Administrative Officer IV (SG 22) under the City Mayor's Office.

Section 3. Funding for the New Position.

a. Administrative Officer IV. The corresponding fund for the salary and other emoluments and benefits for the said position shall be provided in the ensuing Annual Budget of Tuguegarao City subject however to Personnel Services limitations.

Section 4. Qualifications. All matters pertinent to recruitment and placement for the above created position shall be governed by Civil Service laws, rules and regulations, and other related issuances.

Section 5. Effectivity. This Ordinance shall take effect upon its approval.
