CITY ORDINANCE NO. 53-08-2019

ORDINANCE TRANSFERRING THE PLANTILLA POSITION OF SUPERVISING ADMINISTRATIVE OFFICER IV FROM THE CITY MAYOR'S OFFICE TO THE TUGUEGARAO CITY PEOPLE'S GENERAL HOSPITAL

WHEREAS, Section 76 of RA 7160, otherwise known as the Local Government Code of 1991, empowers LGUs to design and implement their own organizational structure and staffing pattern that will effectively address their development plans, objectives and priorities;

WHEREAS, Section 11(c), Rule IV of 2017 Omnibus Rules on Appointment and other Human Resource Actions (ORA OHRA) revised in 2018 provides that "...the movement of employee from one position to another which is of equivalent rank, level or salary without gap in the service involving the issuance of an appointment. The transfer may be from one organizational unit to another in the same department or agency or from one department to or agency to another: Provided, however, that any movement from the non-career service and vice versa shall not be considered as a transfer but reappointment";

WHEREAS, the Plantilla Position of Supervising Administrative Officer IV is transferred from the Office of the City Mayor to the Tuguegarao City People's General Hospital (TCPGH) and its Plantilla Item No. 1.10 to Item 4.74-A;

WHEREAS, the transfer of Plantilla position from the City Mayor's Office to TCPGH will augment manpower in the TCPGH and improve the delivery of basic services particularly those which have to do with the programs and projects which the City Mayor is empowered to implement and which the Sanggunian is empowered to provide for under the Local Government Code of 1991;

WHEREAS, in the exigency of service and in order to promote efficiency and an effective personnel force, there is a need to transfer the Plantilla Position of Supervising Administrative Officer IV from City Mayor's Office to TCPGH.

NOW, THEREFORE, be it **ORDAINED**, by the Eighth City Council of Tuguegarao in session duly assembled, to enact:

Section 1. Title. This Ordinance shall be known as "*Ordinance Transferring the Plantilla Position of Supervising Administrative Officer IV Under the Office of the City Mayor to the Tuguegarao City People's General Hospital.*"


Section 2. Transfer of Plantilla Positions. The position of Supervising Administrative Officer IV is hereby transferred from the City Mayor's Office to the Tuguegarao City People's General Hospital.

The adjustment may be resorted to without changes in position title, rank or neither requires an appointment as authorized pursuant to Section 12, Rule IV of ORA OHRA.


Section 3. Effectivity. This Ordinance shall take effect upon its approval.
