**CITY ORDINANCE NO. 54-08-2019**

**AN ORDINANCE AMENDING CITY ORDINANCE NO. 039-08-2019 TITLED “AN ORDINANCE AUTHORIZING THE CONDUCT OF NIGHT MARKET ON AN EXPERIMENTAL BASIS ALONG GOMEZ STREET (CORNER BONIFACIO TO CORNER TAFT STREET) FOR A PERIOD OF SIX (6) MONTHS FROM OCTOBER 15, 2019 TO APRIL 15, 2020 FROM 6:00 P.M. TO 1:00 A.M.” TO INCLUDE GONZAGA STREET COVERING BONIFACIO STREET TO BURGOS STREET FROM DECEMBER 17, 2019 TO DECEMBER 31, 2019**

**WHEREAS**, it is permissible under the Local Government Code that a city, municipality or barangay, through an ordinance, may temporarily close or regulate the use of any local street, road, thoroughfare or any other public places where flea or night market may be established and where goods, merchandise, foodstuffs, commodities or articles of commerce may be sold and dispensed to the general public;

**WHEREAS**, due to loss of income as a result of road clearing operations, street vendors were clamoring for the conduct of Night Market while waiting for the completion of the New Tuguegarao City Public Market (Don Domingo);

**WHEREAS**, the City is very concerned with the plight of these small businesspersons and ambulant vendors, however, there is a need to keep all public places clean with unobstructed flow of traffic and free from crimes;

**WHEREAS**, it is practical for local residents and visitors to buy their necessities after working hours up to the late evenings as is being done in urban cities for their convenience and at the same time giving the opportunity for these businesspersons to sell their wares;

**WHEREAS**, for this matter, the Eighth City Council approved City Ordinance 39-08-2019 titled “An Ordinance Authorizing the Conduct of Night Market on an Experimental Basis Along Gomez Street

(Corner Bonifacio to Corner Taft Street) for a Period of Six (6) Months from October 15, 2019 to April 15, 2020 from 6:00 P.M. to 1:00 A.M.” on October 07, 2019;

**WHEREAS**, the City Mayor, Hon. Atty. Jefferson P. Soriano, has requested for an authority from the Eighth City Council to allow additional Night Market Activity along Gonzaga Street covering Bonifacio Street to Burgos Street from December 17, 2019 to December 31, 2019.

**NOW, THEREFORE**, be it **ORDAINED** by the Sangguniang Panlungsod of Tuguegarao City, in session assembled, to enact the following:

**Section 1. TITLE.** This Ordinance shall be known and cited as “*Ordinance Amending City Ordinance No. 039-08-2019 titled “An Ordinance Authorizing the Conduct of Night Market on an Experimental Basis along Gomez Street (Corner Bonifacio to Corner Taft Street) for a period of six (6) months from October 15, 2019 to April 15, 2020 from 6:00 P.M. to 1:00 A.M.” to Include Gonzaga Street Covering Bonifacio Street to Burgos Street from December 17, 2019 to December 31, 2019 .”*”

**Section 2. AUTHORIZATION AND SCOPE.** It is hereby authorized the conduct of Night Market on an Experimental Basis along Gomez Street, Corner Bonifacio Street to Corner Taft Street for a period of six (6) months from October 15, 2019 to April 15, 2020 from 6:00 P.M. to 1:00 A.M. to include Gonzaga Street covering Bonifacio Street to Burgos Street from December 17, 2019 to December 31, 2019, subject to following:

1. For the Market Administrator to come up with an inventory of all street vendors operating at night time before the implementation of this ordinance.
2. The Business Permits and Licensing Office (BPLO) shall be in charge of the registration of vendors and shall control and supervise the activities in the area.
3. Only bonafide residents of Tuguegarao City operating their businesses at night time shall be allowed to sell in the area.
4. The stalls to be put up in the area shall measure 2 meters x 3 meters.
5. Awarding of stalls shall be done by lottery.
6. No vendors shall be allowed to transfer or lease any stall assigned to them for the purpose of gain.
7. There should be no installation of permanent structures in order that, before and after the operation, the place can be made very clean and free from garbage and other obstructions to traffic and pedestrians.
8. The Public Order and Security Unit (POSU), Philippine National Police (PNP) Tuguegarao Station, Bureau of Fire Protection (BFP) Tuguegarao Station and the barangay tanods concerned are hereby tasked to maintain peace and order during the entire duration of the Nigh Market.


**Section 3. COLLECTION OF FEES.** A fee in the amount of Thirty Pesos (P30.00) per stall per night shall be charged from each vendor. The City Treasurer is hereby authorized to collect the said fee which shall accrue to the General Fund.

**Section 4. IMPLEMENTING RULES AND REGULATIONS.** For smooth and effective implementation of this Ordinance, the City Mayor shall adopt the Implementing Rules and Regulations (IRR) immediately upon the effectivity of this Ordinance.


**Section 5. EFFECTIVITY.** This Ordinance shall take effect immediately upon approval.
