
Madam:

APPROPRIATION ORDINANCE NO. 02-08-2020

**ORDINANCE AUTHORIZING SUPPLEMENTAL BUDGET NO. 02
 OF TUGUEGARAO CITY FOR CY 2020**

WHEREAS, Section 458 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, and Article 99 (2)(i) of the Rules and Regulations Implementing the Local Government Code of 1991 provide that the Sangguniang Panlungsod has the power to “approve annual and supplemental budgets of the City Government and appropriate funds for specific programs, projects, services and activities of the city, or for other purposes not contrary to law, in order to promote the general welfare of the city and its inhabitants;”

WHEREAS, DBM Budget Circular No. 2020-1 provides the guidelines on the grant of COVID-19 Hazard Pay while DBM-DILG JMC No. 01 dated March 27, 2020 provides the guidelines on the utilization of the 20% Annual Internal Revenue Allotment for development projects in view of the Corona Virus Disease 2019 Situation;

WHEREAS, City Development Council (CDC) Resolution No. 02, Series of 2020 titled “A Resolution Endorsing to the 8th Tuguegarao City Council the Approval of the Supplemental Annual Investment Program CY 2020 for Supplemental Budget No. 02 CY 2020” was approved through City Resolution No. 127-08-2020 by the Eighth City Council during its 36th Regular Session held on April 06, 2020;

WHEREAS, the City Mayor, Hon. Atty. Jefferson P. Soriano, has endorsed to the Eighth City Council the request for the enactment of an Appropriation Ordinance authorizing the Supplemental Budget No. 02 for CY 2020 in the amount of Thirty-Seven Million Six Hundred Fifty-Six Thousand Pesos (P37,656,000.00) to fund development projects in view of the Corona Virus Disease 2019 Situation as contained in CDC Resolution No. 02, Series of 2020;

WHEREAS, the Local Finance Committee has certified that the amount of Thirty-Seven Million Six Hundred Fifty-Six Thousand Pesos (P37,656,000.00) is free from any obligation and is available for appropriation;

WHEREAS, all development projects in view of the Corona Virus Disease 2019 Situation funded under proposed Supplemental Budget No. 02 are in conformity with the approved Supplemental Annual Investment Program;

WHEREAS, the Hazard Pay of Two Hundred Fifty Pesos (P250.00) to Three Hundred Pesos (P300.00) shall be subject to the allocation of fund for those who actually rendered services from March 16, 2020 to April 14, 2020;

WHEREAS, Supplemental Budget No. 02 of Tuguegarao City for CY 2020 has fully complied with the budgetary requirements and general limitations as provided by Republic Act No. 7160, otherwise known as the Local Government Code of 1991 and other laws.

NOW, THEREFORE, be it **ORDAINED** by the Eighth City Council in session assembled, to enact:

SECTION 1. AUTHORIZATION. Supplemental Budget No. 01 of Tuguegarao City for CY 2020 with a total appropriation of Thirty-Seven Million Six Hundred Fifty-Six Thousand Pesos (P37,656,000.00) is authorized to finance the Priority Programs, Projects and Activities of the City.

SECTION 2. SOURCE OF APPROPRIATION. The Appropriation shall be sourced out from Realignment from Appropriation and Realignment of 20% Development Fund amounting to of Thirty-Seven Million Six Hundred Fifty-Six Thousand Pesos (P37,656,000.00).

SECTION 3. USE OF FUNDS. The amount of Thirty-Seven Million Six Hundred Fifty-Six Thousand Pesos (P37,656,000.00) is hereby appropriated for Supplemental Budget No. 02 of Tuguegarao City for CY 2020 as follows:

SECTION 4. CONDITION. The disbursements of funds shall be made subject to the usual accounting, auditing and procurement laws, rules and regulations.



WHEREAS, His Excellency President Rodrigo Roa Duterte issued Proclamation No. 929 on March 16, 2020 declaring a State of Calamity throughout the Philippines in view of the escalating and continuous rise of confirmed COVID-19 cases despite government interventions;




