

APPROPRIATION ORDINANCE NO. 03-08-2020

**ORDINANCE AUTHORIZING SUPPLEMENTAL BUDGET NO. 03
 OF TUGUEGARAO CITY FOR CY 2020**

WHEREAS, Section 458 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, and Article 99 (2)(i) of the Rules and Regulations Implementing the Local Government Code of 1991 provide that the Sangguniang Panlungsod has the power to “approve annual and supplemental budgets of the City Government and appropriate funds for specific programs, projects, services and activities of the city, or for other purposes not contrary to law, in order to promote the general welfare of the city and its inhabitants;”

WHEREAS, Local Budget Circular No. 125-2020 provides Guidelines on the Release and Utilization on the Bayanihan Grant to Cities and Municipalities in which Tuguegarao City is one of the recipients;

WHEREAS, the said Bayanihan Grant shall be used solely to fund priority plans, projects and activities to fight COVID-19 in Tuguegarao City;

WHEREAS, City Development Council (CDC) Resolution No. 03, Series of 2020 titled “Resolution Endorsing to the 8th Tuguegarao City Council the Approval of the Supplemental Annual Investment Program CY 2020 for Supplemental Budget No. 03 CY 2020” was adopted and approved through City Resolution No. 133-08-2020 by the Eighth City Council during its 37th Regular Session held on April 14, 2020;

WHEREAS, the City Mayor, Hon. Atty. Jefferson P. Soriano, has endorsed to the Eighth City Council the request for the enactment of an Appropriation Ordinance authorizing Supplemental Budget No. 03 for CY 2020 in the amount of Fifty-Five Million Nine Hundred Ninety-Eight Thousand Five Hundred

Thirty-One Pesos (P55,998,531.00) to fund the priority plans, projects and activities as contained in CDC Resolution No. 03, Series of 2020;

WHEREAS, the Local Finance Committee has certified that the amount of Fifty-Five Million Nine Hundred Ninety-Eight Thousand Five Hundred Thirty-One Pesos (P55,998,531.00) is free from any obligation and is available for appropriation;

WHEREAS, all priority plans, projects and activities in view of the Corona Virus Disease 2019 Situation funded under proposed Supplemental Budget No. 03 are in conformity with the approved Supplemental Annual Investment Program;

WHEREAS, Supplemental Budget No. 03 of Tuguegarao City for CY 2020 has fully complied with the budgetary requirements and general limitations as provided by Republic Act No. 7160, otherwise known as the Local Government Code of 1991 and other laws.

NOW, THEREFORE, be it **ORDAINED** by the Eighth City Council in session assembled, to enact:

SECTION 1. AUTHORIZATION. Supplemental Budget No. 03 of Tuguegarao City for CY 2020 with a total appropriation of Fifty-Five Million Nine Hundred Ninety-Eight Thousand Five Hundred Thirty-One Pesos (P55,998,531.00) is authorized to finance the Priority Programs, Projects and Activities to fight COVID-19 in Tuguegarao City.

SECTION 2. SOURCE OF APPROPRIATION. The Appropriation shall be sourced out from Bayanihan Grants to Cities and Municipalities amounting to Fifty-Five Million Nine Hundred Ninety-Eight Thousand Five Hundred Thirty-One Pesos (P55,998,531.00).

SECTION 3. USE OF FUNDS. The amount of Fifty-Five Million Nine Hundred Ninety-Eight Thousand Five Hundred Thirty-One Pesos (P55,998,531.00) is hereby appropriated for Supplemental Budget No. 03 of Tuguegarao City for CY 2020 as follows:


SECTION 5. CONDITION. The disbursements of funds shall be made subject to the usual accounting, auditing and procurement laws, rules and regulations.


