**APPROPRIATION ORDINANCE NO. 05-08-2020**

**ORDINANCE AUTHORIZING SUPPLEMENTAL BUDGET NO. 05  
 OF TUGUEGARAO CITY FOR CY 2020**

**WHEREAS**, Section 458 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, and Article 99 (2)(i) of the Rules and Regulations Implementing the Local Government Code of 1991 provide that the Sangguniang Panlungsod has the power to “approve annual and supplemental budgets of the City Government and appropriate funds for specific programs, projects, services and activities of the city, or for other purposes not contrary to law, in order to promote the general welfare of the city and its inhabitants;”

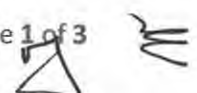
**WHEREAS**, President Rodrigo Roa Duterte has issued Proclamation No. 922 declaring a State of Public Health Emergency throughout the Philippines;

**WHEREAS**, DBM-DILG JMC No. 01 dated March 27, 2020 provides the guidelines on the utilization of the 20% Annual Internal Revenue Allotment for development projects in view of the Corona Virus Disease 2019 (COVID-19) Situation;

**WHEREAS**, there is an amount of Twenty-One Million One Hundred Thousand Pesos (P21,100,000.00) which is free from any obligation and is available for appropriation;

**WHEREAS**, there is a need to realign the funds for programs, projects and activities under the Office of the City Mayor to address and respond to the COVID-19 emergencies and other services of the local government unit of Tuguegarao City;

**WHEREAS**, City Development Council (CDC) Resolution No. 05, Series of 2020 titled “Resolution Endorsing to the 8<sup>th</sup> Tuguegarao City Council the Approval of Supplemental Annual Investment Program CY 2020 for Supplemental Budget No. 05 CY 2020” was adopted and approved through City



Resolution No. 181-08-2020 by the Eighth City Council during its 50<sup>th</sup> Regular Session held on July 21, 2020;

**WHEREAS**, the City Mayor, Hon. Atty. Jefferson P. Soriano, has endorsed to the Eighth City Council the request for the enactment of an Appropriation Ordinance authorizing Supplemental Budget No. 05 for CY 2020 in the amount of Twenty One Million One Hundred Thousand Pesos (P21,100,000.00) to fund the priority plans, projects and activities as contained in CDC Resolution No. 05, Series of 2020;

**WHEREAS**, the Local Finance Committee has certified that the amount of Twenty-One Million One Hundred Thousand Pesos (P21,100,000.00) is free from any obligation and is available for appropriation;

**WHEREAS**, all priority plans, projects and activities in view of the Corona Virus Disease 2019 Situation funded under proposed Supplemental Budget No. 05 are in conformity with the approved Supplemental Annual Investment Program;

**WHEREAS**, Supplemental Budget No. 05 of Tuguegarao City for CY 2020 has fully complied with the budgetary requirements and general limitations as provided by Republic Act No. 7160, otherwise known as the Local Government Code of 1991 and other laws.

**NOW, THEREFORE**, be it **ORDAINED** by the Eighth City Council in session assembled, to enact:

**SECTION 1. AUTHORIZATION.** Supplemental Budget No. 05 of Tuguegarao City for CY 2020 with a total appropriation of Twenty-One Million One Hundred Thousand Pesos (P21,100,000.00) is authorized to finance the Priority Programs, Projects and Activities to fight COVID-19 in Tuguegarao City.

**SECTION 2. SOURCE OF APPROPRIATION.** The Appropriation shall be sourced out from the Realignment from OMOE Appropriation, 20% Development Fund and Capital Outlay of the Office of the City Mayor amounting to Twenty-One Million One Hundred Thousand Pesos (P21,100,000.00).

**SECTION 3. USE OF FUNDS.** The amount of Twenty-One Million One Hundred Thousand Pesos (P21,100,000.00) is hereby appropriated for Supplemental Budget No. 05 of Tuguegarao City for CY 2020 as follows:


**SECTION 4. CONDITION.** The disbursements of funds shall be made subject to the usual accounting, auditing and procurement laws, rules and regulations.


**SECTION 6. EFFECTIVITY.** This Appropriation Ordinance shall take effect immediately upon its approval.


