APPROPRIATION ORDINANCE NO. 06-08-2020

ORDINANCE AUTHORIZING SUPPLEMENTAL BUDGET NO. 06 OF TUGUEGARAO CITY FOR CY 2020

WHEREAS, Section 458 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, and Article 99 (2)(i) of the Rules and Regulations Implementing the Local Government Code of 1991 provide that the Sangguniang Panlungsod has the power to "approve annual and supplemental budgets of the City Government and appropriate funds for specific programs, projects, services and activities of the city, or for other purposes not contrary to law, in order to promote the general welfare of the city and its inhabitants;"

WHEREAS, priority programs, projects and activities need additional funding for completion, efficiency and effectiveness of services and facilities of the local government unit of Tuguegarao City;

WHEREAS, City Development Council (CDC) Resolution No. 14, Series of 2020 titled "Resolution Endorsing to the 8th Tuguegarao City Council the Approval of Supplemental Annual Investment Program CY 2020 for Supplemental Budget No. 06 CY 2020" was adopted and approved through City Resolution No. 227-08-2020 by the Eighth City Council during its Special Session held on October 08, 2020;

WHEREAS, the City Mayor, Hon. Atty. Jefferson P. Soriano, has endorsed to the Eighth City Council the request for the enactment of an Appropriation Ordinance authorizing Supplemental Budget No. 06 for CY 2020 in the amount of Twenty-Seven Million Eight Hundred Forty Thousand Pesos (P27,840,000.00) to fund the priority plans, projects and activities as contained in CDC Resolution No. 14, Series of 2020;

WHEREAS, the City Treasurer and the City Accountant certified that the amount of Twenty-Seven Million Eight Hundred Forty Thousand Pesos (P27,840,000.00) is free from any obligation and is available for appropriation;

WHEREAS, Supplemental Budget No. 06 of Tuguegarao City for CY 2020 has fully complied with the budgetary requirements and general limitations as provided by Republic Act No. 7160, otherwise known as the Local Government Code of 1991 and other laws.

NOW, THEREFORE, be it ORDAINED by the Eighth City Council in session assembled, to enact:

SECTION 1. AUTHORIZATION. Supplemental Budget No. 06 of Tuguegarao City for CY 2020 with a total appropriation of Twenty-Seven Million Eight Hundred Forty Thousand Pesos (P27,840,000.00) is authorized to finance the Priority Programs, Projects and Activities of the local government unit in Tuguegarao City.

SECTION 2. SOURCE OF APPROPRIATION. The Appropriation shall be sourced out from the Savings from Appropriation, Maintenance and Other Operating Expenses, Capital Outlay and Continuing Appropriation of the Office of the City Mayor amounting to Twenty-Seven Million Eight Hundred Forty Thousand Pesos (P27,840,000.00).

SECTION 3. USE OF FUNDS. The amount of Twenty-Seven Million Eight Hundred Forty Thousand Pesos (P27,840,000.00) is hereby appropriated for Supplemental Budget No. 06 of Tuguegarao City for CY 2020 as follows:

SECTION 6. EFFECTIVITY. This Appropriation Ordinance shall take effect immediately upon its approval.
