**CITY ORDINANCE NO. 19-08-2020**

**AN ORDINANCE REGULATING THE OPERATION OF TRICYCLES IN THE CITY WITHIN THE PERIOD OF THE GENERAL COMMUNITY QUARANTINE (GCQ) AND SUSPENDING FOR THE MEANTIME THE EXISTING FARE MATRIX OF CITY ORDINANCE NO. 21-2018**

**WHEREAS**, from an Enhanced Community Quarantine (ECQ) wherein people are restricted to their respective houses 24/7, Tuguegarao City is now shifting to General Community Quarantine (GCQ) wherein certain establishments are not allowed to open and people from ages 20 to 59 are now allowed outside of their houses, only to access basic necessities;

**WHEREAS**, the basic public transport facility within the city is the tricycle;

**WHEREAS**, with the shift to GCQ, tricycles may now start operating but only for a very limited number of days within a month;

**WHEREAS**, there was a proper consultation with all the Presidents of the Tricycle Operators and Drivers Association (TODA) of Tuguegarao City on April 27, 2020 at 10:00 AM at the lobby of the city hall.

**NOW, THEREFORE, RESOLVE**, as it is hereby **RESOLVED**, to enact this City Ordinance allowing the operation of tricycles within the city but only on a strictly limited period and passenger capacity:

**Section 1. Title.** This Ordinance shall be called “*An Ordinance Regulating the Operation of Tricycles in the City Within the Period of General Community Quarantine (GCQ) and Suspending for the Meantime the Existing Fare Matrix of City Ordinance No. 21-2018*”.

**Section 2.** The operation of tricycles shall follow the body number-ending scheme on a calendar date basis, to wit:

- a. Those ending in the number one (1), shall operate only on the calendar dates 1, 11, 21 and 31;
- b. Those ending in the number two (2), shall operate only on the calendar dates 2, 12 and 22;
- c. Those ending in the number three (3), shall operate only on the calendar dates 3, 13 and 23;
- d. Those ending in the number four (4), shall operate only on the calendar dates 4, 14 and 24;
- e. Those ending in the number five (5), shall operate only on the calendar dates 5, 15 and 25;
- f. Those ending in the number six (6), shall operate only on the calendar dates 6, 16 and 26;
- g. Those ending in the number seven (7), shall operate only on the calendar dates 7, 17 and 27;
- h. Those ending in the number eight (8), shall operate only on the calendar dates 8, 18 and 28;
- i. Those ending in the number nine (9), shall operate only on the calendar dates 9, 19 and 29; and,
- j. Those ending in the number zero (0), shall operate only on the calendar dates 10, 20 and 30.

**Section 3. Exceptions.** The following tricycles are exempted from the foregoing body number-ending scheme:

- a. Tricycles conveying passenger/s in an emergency situation to hospitals and the like; and,
- b. Tricycles conveying a market vendor to the Don Domingo Public Market to buy from wholesale vendors for retail in a satellite market (talipapa), in sari-sari store or in the established Satellite Markets. In which case the tricycle driver and its passenger shall be issued a travel pass if one has not been issued beforehand on a monthly basis.

**Section 4. Fare Rates During GCQ Period.** The fare rates based from City Ordinance No. 21-2018 titled “An Ordinance Fixing Fare Rates for Tricycles for Hire Operating Within Tuguegarao City” will be the following:

- P12.00 will be adjusted to P25.00;
- P14.00 will be adjusted to P50.00; and,
- P18.00 will be adjusted to P75.00.

The minimum fare rate is P25.00 while the maximum is P75.00.

**Section 5. Operational requirements/restrictions.**

- a. Tricycle drivers shall wear at all times a protective facial mask and to make available a bottle of alcohol for hand disinfection;
- b. Tricycle drivers shall not pick-up and ferry passengers who do not wear protective face masks; and,
- c. Tricycle drivers are strictly prohibited from carrying/conveying more than one (1) passenger.


**Section 6. Penalty Clause.** Any tricycle driver/operator violating any of the provisions of this ordinance shall suffer the penalty of having the tricycle impounded for the entire duration of the GCQ.

**SECTION 7. Separability Clause.** This Ordinance shall temporarily suspend the implementation of certain applicable provisions under the existing Tricycle Code of Tuguegarao City.

**Section 8. Effectivity Clause.** This ordinance shall take effect on May 1, 2020 until the existence of the GCQ in Tuguegarao City or the Province of Cagayan.
