**CITY ORDINANCE NO. 26-08-2020**

**AN ORDINANCE CONDONING THE RENTALS OF STALLS AT THE TUGUEGARAO CITY COMMERCIAL CENTER (TCCC) AND PEOPLE'S GYMNASIUM IN VIEW OF THE ENHANCED COMMUNITY QUARANTINE (ECQ)**

**WHEREAS**, the World Health Organization (WHO) declared on March 12, 2020 that COVID-19 has become a "pandemic";

**WHEREAS**, President Rodrigo Roa Duterte has issued Executive Order No. 922 declaring a State of Public Health Emergency due to novel corona virus disease (COVID19) and subsequently ordered for the Enhanced Community Quarantine (ECQ) of the entire Luzon;

**WHEREAS**, on the basis of the above orders, the Eighth City Council passed and approved City Resolution No. 097-08-2020 "Resolution Adopting and Approving City Disaster Risk Reduction and Management Council Resolution No. 02-2020 titled "Resolution Recommending the Declaration of Tuguegarao City under a state of Public Health Emergency due to the Threat of Corona Virus Disease (COVID) 2019";

**WHEREAS**, the City Mayor, Hon. Atty. Jefferson P. Soriano, has issued Executive Order No. 28, series of 2020 "An Order Implementing the Strict Home Quarantine in All Households Beginning March 17, 2020 to April 14, 2020 in Tuguegarao City";

**WHEREAS**, on March 16, 2020, President Rodrigo Duterte declared a state of calamity in the Philippines for six months through Proclamation No. 929 as cases of the novel coronavirus in the country continue to rise;

**WHEREAS**, relative to the above premises, work-from-home arrangements have been made while most establishments were directed to close;



**WHEREAS**, the 8<sup>th</sup> City Council approved City Resolution No. 100-08-2020 titled “*Resolution Granting One-Month Rental Condonation of Stalls at the Tuguegarao City Commercial Center (TCCC) and People’s Gymnasium from March 20, 2020 to April 20, 2020.*”

**WHEREAS**, the National Government extended the Enhanced Community Quarantine in the entire Luzon up to April 30, 2020 due the rising cases of COVID 19, hence, the approval of City Resolution No. 146-08-2020.

**WHEREAS**, there is a need to enact an Ordinance for the condonation of the rentals of the stalls at the Tuguegarao City Commercial Center and People’s Gymnasium in view of the Enhanced Community Quarantine (ECQ) and Extended Enhanced Community Quarantine (GCQ).

**NOW, THEREFORE**, be it **ORDAINED**, as it is hereby **ORDAINED**, by the Eighth City Council in Tuguegarao City, in session duly assembled to enact the following:

**Section 1. Title.** This Ordinance shall be referred to as “*An Ordinance Condoning the Rentals of Stalls at the Tuguegarao City Commercial Center and People’s Gymnasium in View of the Enhanced Community Quarantine (ECQ).*”

**Section 2. Period of Condonation.** The condonation of rentals shall be effective for the entire duration of the Enhanced Community Quarantine (ECQ) from March 20, 2020 to April 20, 2020 and from April 21, 2020 to April 30, 2020 in view of the Extended Enhanced Community Quarantine.


**Section 3. Separability Clause.** The provisions of this ordinance are hereby declared to be separable; in the event that one or more of the provisions are held illegal or unconstitutional, the validity of the other provisions shall not be affected.

**Section 4. Repealing Clause.** City Resolution No. 146-08-2020 titled “*Resolution Extending the Rental Condonation of Stalls at the Tuguegarao City Commercial Center (TCCC) and People’s Gymnasium from April 21, 2020 to April 30, 2020 in View of the Extended Enhanced Community Quarantine*” and City Resolution No. 100-08-2020 titled “*Resolution Granting One-Month Rental Condonation of Stalls at the Tuguegarao City Commercial Center (TCCC) and People’s Gymnasium from March 20, 2020 to April 20, 2020*” are hereby repealed accordingly.

**Section 5. Effectivity.** This Ordinance shall take effect upon its approval and in accordance with the provisions of the Local Government Code.
