### CITY ORDINANCE NO. 030-08-2020

## CITY ORDINANCE EXTENDING THE DEADLINES FOR THE PAYMENT OF TAXES, FEES AND CHARGES IN TUGUEGARAO CITY PURSUANT TO "BAYANIHAN TO HEAL AS ONE ACT"

WHEREAS, the Bureau of Local Government Finance of the Department of Finance has issued Memorandum Circular No. 010-2020 dated April 30, 2020 on the Extension of Deadlines for the Payment of Taxes, Fees and Charges of LGUs pursuant to Section 4(z) of RA No. 11469, per DC No. 002-2020;

WHEREAS, the said Memorandum Circular mandates Local Government Units to extend the deadlines for the payment of taxes, fees and charges imposed and collected until 25 June 2020 and providing guidelines therefor;

WHEREAS, the City Mayor, Hon. Atty. Jefferson P. Soriano, indorsed the said Memorandum Circular to the Eighth City Council for information and appropriate action on May 21, 2020; and

WHEREAS, the 8th City Council finds it necessary and beneficial to the taxpayers badly affected by COVID-19 to extend the deadline to June 30, 2020.

NOW, THEREFORE, be it ORDAINED, as it is hereby ORDAINED, by the Eighth City Council in Tuguegarao City, in session duly assembled to enact the following:

Section 1. Title. This Ordinance shall be referred to as "CITY ORDINANCE EXTENDING THE DEADLINES FOR THE PAYMENT OF TAXES, FEES AND CHARGES IN TUGUEGARAO CITY PURSUANT TO "BAYANIHAN TO HEAL AS ONE ACT."

Section 2. Legal Bases: This Ordinance is pursuant to the following:

- Department Circular No. 002-2020 of the Department of Finance on the extension of deadlines for the payment of taxes, fees and charges of local government units (LGUs) pursuant to Section 4 (2) of Republic Act No. 11469, otherwise known as the "Bayanihan to Heal as One Act."
- Memorandum Circular No. 010-2020 of the Bureau of Local Government Finance of the Department of Finance dated April 30, 2020 on the Extension of Deadlines for the Payment of Taxes, Fees and Charges of LGUs pursuant to Section 4(z) of RA No. 11469, per DC No. 002-2020.
- Section 3. Extension. The extension of deadlines for the payment of taxes, fees and charges imposed and collected by the City Government of Tuguegarao shall be until June 30, 2020.
- Section 4. Implementation. The Office of the City Assessor, Office of the City Treasurer and the Office of the Business Permits and Licensing Office are hereby tasked to implement and enforce the provisions of this Ordinance.
- Section 5. Separability Clause. The provisions of this ordinance are hereby declared to be separable; in the event that one or more of the provisions are held illegal or unconstitutional, the validity of the other provisions shall not be affected.
- **Section 6. Repealing Clause**. Ordinances, executive orders and other local legislations inconsistent with this Ordinance are hereby modified or repealed accordingly.
- Section 7. Effectivity. This Ordinance shall take effect upon its approval and in accordance with the above-stated legal bases and the applicable provisions of the Local Government Code.
