**AN ORDINANCE AMENDING CITY ORDINANCE NO. 26-08-2020 TITLED “AN ORDINANCE
 CONDONING THE RENTALS OF STALLS AT THE TUGUEGARAO CITY COMMERCIAL
 CENTER (TCCC) AND PEOPLE’S GYMNASIUM IN VIEW OF THE ENHANCED
 COMMUNITY QUARANTINE (ECQ)”, THAT INSTEAD OF MARCH 20, 2020 AS THE
 STARTING PERIOD, IT SHALL BE MARCH 16, 2020**

WHEREAS, President Rodrigo Roa Duterte has issued Executive Order No. 922 declaring a State of Public Health Emergency due to novel corona virus disease (COVID-19) after the World Health Organization (WHO) declared on March 12, 2020 that it has become a “pandemic” and subsequently placed the entire Luzon under Enhanced Community Quarantine (ECQ);

WHEREAS, the Eighth City Council has approved City Resolution No. 097-08-2020 “Resolution Adopting and Approving City Disaster Risk Reduction and Management Council Resolution No. 02-2020 titled “Resolution Recommending the Declaration of Tuguegarao City under a state of Public Health Emergency due to the Threat of Corona Virus Disease (COVID) 2019”;

WHEREAS, the City Mayor, Hon. Atty. Jefferson P. Soriano, has issued Executive Order No. 28, series of 2020 “An Order Implementing the Strict Home Quarantine in All Households Beginning March 17, 2020 to April 14, 2020 in Tuguegarao City”;

WHEREAS, relative to the above premises, work-from-home arrangements have been made while most establishments including those stalls at the Tuguegarao City Commercial Center (TCCC) and People's Gymnasium were directed to close;

WHEREAS, in view of this, the 8th City Council enacted City Ordinance No. 26-08-2020 titled "An Ordinance Condoning the Rentals of Stalls at the Tuguegarao City Commercial Center (TCCC) and People's Gymnasium in View of the Enhanced Community Quarantine (ECQ)", from March 20, 2020 to April 30, 2020; and

WHEREAS, there is a need to amend the said ordinance to make it congruent with the start of the Enhanced Community Quarantine.

NOW, THEREFORE, be it **ORDAINED**, as it is hereby **ORDAINED**, by the Eighth City Council in Tuguegarao City, in session duly assembled to enact the following:

Section 1. Title. This Ordinance shall be referred to as *An Ordinance Amending City Ordinance No. 26-08-2020 titled "An Ordinance Condoning the Rentals of Stalls at the Tuguegarao City Commercial Center (TCCC) and People's Gymnasium in View of the Enhanced Community Quarantine (ECQ)", that instead of March 20, 2020 as the Starting Period, it shall be March 16, 2020.*

Section 2. Period of Condonation. Section 2 of City Ordinance No. 26-08-2020 shall be amended as follows:

The condonation of rentals shall be effective from March 16, 2020 to April 20, 2020 due to the Enhanced Community Quarantine and from April 21, 2020 to April 30, 2020 in view of the Extended Enhanced Community Quarantine.


Section 3. Exception. Stalls which have opened during the said dates shall have to pay their rentals.

Section 4. Separability Clause. The provisions of this ordinance are hereby declared to be separable; in the event that one or more of the provisions are held illegal or unconstitutional, the validity of the other provisions shall not be affected.


Section 5. Effectivity. This Ordinance shall take effect upon its approval and in accordance with the provisions of the Local Government Code.
