CITY ORDINANCE NO. 032-08-2020

AN ORDINANCE CONDONING THE RENTALS OF STALLS WHICH ARE STILL CLOSED WHILE GIVING FIFTY PERCENT (50%) DISCOUNT TO THOSE WHICH ARE NOW OPERATING AT THE TUGUEGARAO CITY COMMERCIAL CENTER (TCCC) AND PEOPLE'S GYMNASIUM IN THIS MONTH OF MAY 2020 IN VIEW OF THE GENERAL COMMUNITY QUARANTINE

WHEREAS, Tuguegarao City was placed under General Community Quarantine (GCQ) starting May 1, 2020 based from the recommendation of the Inter-Agency Task Force for the Management of Emerging Infectious Diseases that low-risk and moderate-risk areas be placed under GCQ;

WHEREAS, under GCQ, there are still establishments which are not permitted to open and although people from ages 20 to 59 are now allowed outside of their houses, but only to buy the basic necessities for their families;

WHEREAS, in view of the restrictions imposed by GCQ, there are a number of stalls at the Tuguegarao City Commercial Center (TCCC) and People's Gymnasium which remain to be closed in this Month of May 2020;

WHEREAS, the income of those stalls which have started to operate again during the same month has been badly affected, too; and

WHEREAS, in view of their circumstances, there is a need to give the stall holders the chance to recover their losses through giving them special considerations.

NOW, THEREFORE, be it **ORDAINED**, as it is hereby **ORDAINED**, by the Eighth City Council in Tuguegarao City, in session duly assembled to enact the following:

Section 1. Title. This Ordinance shall be referred to as "An Ordinance Condoning the Rentals of Stalls which are still Closed while Giving Fifty Percent (50%) Discount to Those which are now Operating at the Tuguegarao City Commercial Center (TCCC) and People's Gymnasium for the Month of May 2020 in View of the General Community Quarantine."

Section 2. Period of Condonation for the Stalls which are still Closed. The condonation of rentals for the stalls which are still closed in this Month of May 2020 at the Tuguegarao City Commercial Center (TCCC) and People's Gymnasium shall be effective from May 1, 2020 to May 31, 2020.

Section 3. Period of the 50% Discount for Stalls which are now Operating. The 50% Discount on rentals of stalls which are now operating in this Month of May 2020 at the Tuguegarao City Commercial Center (TCCC) and People's Gymnasium shall be effective from May 1, 2020 to May 31, 2020.


Section 4. The Market Administrator and the City Treasurer shall implement a mechanism to check and verify which stalls are still closed and which stalls are already operating to determine whether to condone their rentals or to give them 50% discount.

Section 5. Separability Clause. The provisions of this ordinance are hereby declared to be separable; in the event that one or more of the provisions are held illegal or unconstitutional, the validity of the other provisions shall not be affected.

Section 6. Effectivity. This Ordinance shall take effect upon its approval and in accordance with the provisions of the Local Government Code.
