**CITY ORDINANCE NO. 033-08-2020**

**AN ORDINANCE REPEALING CITY ORDINANCE NO. 028-08-2020 TITLE “AN ORDINANCE ALLOWING A BACKRIDER IN SINGLE MOTORCYCLES AND PROVIDING GUIDELINES AND PENALTIES”**

**WHEREAS**, the City Mayor, Hon. Atty. Jefferson P. Soriano, has endorsed to the 8<sup>th</sup> City Council his request for the passage of a city ordinance allowing a backrider in single motorcycles and providing guidelines and penalties;

**WHEREAS**, the Chairman of the Inter-Agency Task Force for COVID-19 -RO2, Director Dante D. Balao, upon the written request of the City Mayor, has agreed for the backriding for the benefit of the low-income households provided guidelines shall be implemented;

**WHEREAS**, the 8<sup>th</sup> City Council approved on May 19, 2020 City Ordinance No. 28-08-2020 titled “An Ordinance Allowing a Backrider in Single Motorcycles and Providing Guidelines and Penalties”;

**WHEREAS**, DILG Memorandum Circular No. 2020-083 with subject “Guidelines for Local Government Units on the Regulation of Public Transportation” issued on May 18, 2020 provides that the “No Backrider Policy” shall be implemented throughout the country to enable social distancing;

**WHEREAS**, because of the said Memorandum Circular, the City Mayor, Hon. Jefferson P. Soriano, has issued Executive Order No. 61-2020 repealing Executive Order No. 56-2020 which allowed backriding on single motorcycles in Tuguegarao City provided the riders are family members living in one and the same household; and

**WHEREAS**, the City Mayor has indorsed the said Executive Order No. 61-2020 to the 8<sup>th</sup> City Council for information and perusal.


NOW, THEREFORE, be it **ORDAINED** by the Eighth City Council in session duly assembled, to enact:

**Section 1. Repeal.** City Ordinance No. 28-08-2020 titled “An Ordinance Allowing a Backrider in Single Motorcycles and Providing Guidelines and Penalties” is hereby repealed in its entirety.


**Section 2. Effectivity.** This ordinance shall take effect immediately.
