CITY ORDINANCE NO. 036-08-2020

AN ORDINANCE AMENDING SECTION 3 OF CITY ORDINANCE NO. 24-08-2020 TITLED “AN ORDINANCE AMENDING CITY ORDINANCE NO. 22-08-2020 TITLED “AN ORDINANCE PRESCRIBING GUIDELINES FOR THE STRICT OBSERVANCE OF THE GENERAL COMMUNITY QUARANTINE (GCQ) PROTOCOLS AND PROVIDING PENALTIES FOR VIOLATIONS THEREOF”

WHEREAS, on May 06, 2020, City Ordinance No. 22-08-2020 was enacted and was amended by City Ordinance No. 24-08-2020 on May 09, 2020, Section 3 thereof reads as follows:

“Section 3. General Requirement. All persons going out of their residences, and those in public and workplaces, shall at all times wear a protective face mask and shall strictly maintain a safe distance (at least two meters) from one another (social distancing).”

WHEREAS, it has been observed that many business establishments and offices are not strictly complying with this safety requirements during this period of crisis, thus endangering the general public at risk of contamination from COVID-19;

WHEREAS, there is a need to strictly enforce the wearing of protective face mask at all times while outside of residence.

NOW, THEREFORE, be it **ORDAINED** by the Eighth City Council, in session assembled, to enact:

Section 1. Title. This Ordinance shall be known as “An Ordinance Amending Section 3 of City Ordinance No. 24-08-2020 Titled “An Ordinance Amending City Ordinance No. 22-08-2020 Titled “An Ordinance Prescribing Guidelines for the Strict Observance of the General Community Quarantine (GCQ) Protocols and Providing Penalties for Violations Thereof.”

Section 2. Amendment. Section 3 of City Ordinance No. 24-08-2020 is hereby amended and to be read as follows:

“Section 3. General Requirement. All persons going out of their residences, and those in public and workplaces, shall at all times wear a protective face mask and shall strictly maintain a safe distance (at least two meters) from one another (social distancing).”

Section 3A. All business establishments are hereby required to strictly require their customers, their employees, including owners and proprietors, to wear protective face mask inside their business establishments at all times.

Section 3B. No customer or employee of the business establishment shall be allowed to enter the establishment without face mask.

Section 3C. Any business establishment violating the provisions of this Ordinance shall:

- a. For the first offense, pay a fine of P3,000.00; and,*
- b. For the second offense, CLOSURE OF BUSINESS.*

Section 3. Separability Clause. If any part or provision of this Ordinance shall be held to be unconstitutional or invalid, other parts or provisions hereof which are not affected thereby shall remain in full force and effect.


Section 4. Repealing Clause. All ordinances and administrative regulations or part/s thereof which are inconsistent with any provisions of this ordinance are hereby repealed, amended or modified accordingly.

Section 5. Dissemination. Copies of this Ordinance shall be posted in conspicuous places in the city while the City Information Office is directed to cause its dissemination.


Section 6. Effectivity. This Ordinance shall take effect immediately upon its approval until the community quarantine shall be lifted by the National Government.
