CITY ORDINANCE NO. 39-08-2020

**AN ORDINANCE FURTHER AMENDING CITY ORDINANCE NO. 38-08-2020 TITLED
 “AN ORDINANCE AMENDING ORDINANCE NO. 14-08-2020 TO INCLUDE
 THE IMPROPER WEARING OF FACE MASK AS ONE OF THE VIOLATIONS”**

WHEREAS, on June 09, 2020, during the 44th Regular Session of the Eighth City Council, City Ordinance No. 38-08-2020 titled “*An Ordinance Amending City Ordinance No. 14-08-2020 to Include the Improper Wearing of Face Mask as One of the Violations*”;

WHEREAS, it is essential to define “improper wearing” of face mask in order to make it specific to avoid several interpretations;

WHEREAS, it is also imperative to designate the duly authorized officers who shall act as marshals and implementers of the Ordinance during any stage or category of a “community quarantine.”

NOW, THEREFORE, be it **ORDAINED** by the Eighth City Council in session assembled to enact the following City Ordinance:

Section 1. Title. This Ordinance shall be known as “*An Ordinance Further Amending City Ordinance No. 38-08-2020 Titled “An Ordinance Amending Ordinance No. 14-08-2020 to Include the Improper Wearing of Face Mask as One of the Violations.”*”

Section 2. Definition of Term “improper wearing” of face mask – the proper wearing of a face mask is such that the mask shall cover the nose and the mouth in order to contain the aerial spread of bacteria or virus by the person wearing the face mask. Hence, “improper wearing” of face mask would be such that the mask will not entirely cover the nose and mouth or it is just left dangling from one ear to the other without covering neither the nose or the mouth or both or any form of wearing which is not defined herein as proper.




Section 3. For purposes of implementation, the following are hereby authorized:

- a. Barangay Chairs/Punong Barangays and all the Barangay Councilors, are tasked to implement this ordinance in their respective Barangays and are, therefore, duly deputized to apprehend violators and impose the corresponding penalty under Section 5 and 5.a of City Ordinance No. 38-08-2020; fines collected as penalties shall accrue to their Barangay fund.
- b. Tuguegarao PNP Officers and Members of the Public Order and Safety Unit (POSU) Group are hereby authorized to implement this Ordinance within the Centro Barangays and in any part of the territorial jurisdiction of Tuguegarao City; fines collected as penalties by this group of enforcers shall accrue to the City Treasury.
- c. The designated Market Administrator, Mr. Pedro B. Cuntapay, is likewise authorized to implement this Ordinance within the Tuguegarao City Commercial Center and the Tuguegarao City Public Market (Don Domingo) and its satellite markets. Fines collected as penalties by said authorized person shall accrue to the City Treasury.


Section 4. Effectivity. This Ordinance shall take effect immediately upon its approval and shall continue to take effect during any stage or category of the "Community Quarantine".


