CITY ORDINANCE NO. 40-08-2020

AN ORDINANCE APPROVING THE PAYMENT OF JUNE 2020 RENTALS OF THE STALLS AT THE TUGUEGARAO CITY COMMERCIAL CENTER AND PEOPLE’S GYMNASIUM IN SIX (6) EQUAL MONTHLY AMORTIZATIONS IN VIEW OF THE COVID-19 PANDEMIC

WHEREAS, President Rodrigo Roa Duterte has issued Executive Order No. 922 declaring a State of Public Health Emergency due to novel corona virus disease (COVID-19) after the World Health Organization (WHO) declared on March 12, 2020 that it has become a “pandemic” and subsequently placed the entire Luzon under Enhanced Community Quarantine (ECQ);

WHEREAS, Tuguegarao City was placed under ECQ from March 17, 2020 to April 30, 2020 and General Community Quarantine (GCQ) from May 01, 2020 to present;

WHEREAS, in view of the situation, a number of business establishments have been badly affected, thus causing financial crisis and instability to the business owners;

WHEREAS, the lessees of the stalls at the Tuguegarao City Commercial Center and People’s Gymnasium was among those who were heavily affected by the pandemic;

WHEREAS, in consideration of this, the Eighth City Council enacted a number of Ordinances that would help them cope with the situations, to wit:

1. City Ordinance No. 26-08-2020 titled “An Ordinance Condoning the Rentals of Stalls at the Tuguegarao City Commercial Center (TCCC) and People’s Gymnasium in View of the Enhanced Community Quarantine (ECQ)”
2. City Ordinance No. 31-08-2020 titled “An Ordinance Amending City Ordinance No. 26-08-2020 Titled “An Ordinance Condoning the Rentals of Stalls at the Tuguegarao City Commercial Center



(TCCC) and People's Gymnasium in View of the Enhanced Community Quarantine (ECQ)", That Instead of March 20, 2020 as the Starting Period, it Shall be March 16, 2020"

3. City Ordinance No. 32-08-2020 titled "An Ordinance Condoning the Rentals of Stalls Which are Still Closed While Giving Fifty Percent (50%) Discount to Those Which are Now Operating at the Tuguegarao City Commercial Center (TCCC) and People's Gymnasium in this Month of May 2020 in View of the General Community Quarantine"

WHEREAS, the City Mayor, Hon. Atty. Jefferson P. Soriano, endorsed the letter of the stall lessees at the TCCC requesting for a 50% cut in their rentals for June 2020;

WHEREAS, the City Mayor, Hon. Atty. Jefferson P. Soriano, denied the request with the recommendation that instead, the rental fee for the month of June be paid in six (6) equal monthly amortizations, from July to December 2020.

NOW, THEREFORE, be it **RESOLVED**, as it is hereby **RESOLVED**, by the Eighth City Council, that:

Section 1. Title. This Ordinance shall be known as "An Ordinance Approving the Payment of June 2020 Rentals of the Stalls at the Tuguegarao City Commercial Center and People's Gymnasium in Six (6) Equal Monthly Amortizations in View of the Covid-19 Pandemic".

Section 2. Period of Installment. The rental fee for June 2020 shall be paid in six (6) equal amortizations from July to December and shall be added to the rental fees they have to pay in those months.


Section 3. Separability Clause. If, for any reason, a part of this Ordinance is declared illegal or invalid, other parts or provisions hereof which are not affected thereby shall remain valid and in full force and effect.

Section 4. Repealing Clause. All ordinances, rules or regulations in conflict with the provisions of this ordinance are hereby repealed, provided, that the rights already vested under those ordinances, rules or regulations shall not be impaired.


Section 5. Effectivity. Due to its urgency, this ordinance shall take effect upon approval by the Eighth City Council and shall continue to take effect until the lifting of Enhanced Community Quarantine by proper authorities.
