#### CITY ORDINANCE NO. 51-08-2020

AN ORDINANCE AMENDING ORDINANCE NO. 46-08-2020 TITLED AN ORDINANCE IMPOSING NEW CURFEW HOURS IN TUGUEGARAO CITY FROM 12 MIDNIGHT TO 4 AM, PROVIDING EXEMPTIONS AND PENALTIES THEREFOR AND FOR OTHER PURPOSES


WHEREAS, the Province of Cagayan has been placed under Modified General Community Quarantine (MGCQ) starting July 1, 2020 by the Inter-Agency Task Force on Emerging Diseases (IATF-EID);

WHEREAS, the IATF-EIF and the Department of Trade and Industry (DTI) have issued Memorandum Circular Number 20-39 titled "Increasing the Operating Capacity of Dine-in Food Establishments, Amending for the Purpose DTI MC No. 20-37" allowing the operation of dine-in food establishments up to 11 o'clock in the evening;

WHEREAS, the City Mayor, Hon. Atty. Jefferson P. Soriano, requested for the amendment of City Ordinance No. 09-08-2020 Titled "An Ordinance Imposing Curfew in Tuguegarao City from 8 PM to 5 AM, Providing Exemptions and Penalties Therefor and for Other Purposes", further amended by City Ordinance No. 20-08-2020 titled "An Ordinance Amending City Ordinance No. 09-08-2020 Titled "An Ordinance Imposing Curfew in Tuguegarao City from 8 PM to 5 AM, Providing Exemptions and Penalties Therefor and for Other Purposes";

WHEREAS, the Eighth City Council found the request to be with merit and beneficial to the constituents particularly the owners and proprietors of dine-in food establishments;

WHEREAS, Ordinance No. 05-2005 titled "An Ordinance Imposing Curfew Hours for Minors to Prevent Juvenile Delinquency and Providing Penalties for Violation Thereof" shall still be in effect;



NOW, THEREFORE, be it ORDAINED by the Sangguniang Panlungsod in session assembled, to enact:

**SECTION 1. Title**. This Ordinance shall be known as An Ordinance Amending Ordinance No. 46-08-2020 "An Ordinance Imposing New Curfew Hours in Tuguegarao City from 12 Midnight to 4 AM, Providing Exemptions and Penalties Therefor and for Other Purposes."

**SECTION 2.** Curfew. The new curfew hours shall be from 12 Midnight to 4 AM starting July 22, 2020 within the territorial jurisdiction of Tuguegarao City, subject to existing Inter-Agency Task Force for the Management of Emerging Infectious Diseases (IATF-EID) Guidelines.

SECTION 3. Exemption. The following are the exemptions in this order:

- a. Night workers
- b. Health workers and hospital personnel
- c. Authorized government officials and employees like peace officers and elected government officials in the performance of their duties
- Members of the Armed Forces of the Philippines, Philippine National Police, Bureau of Fire Protection and Bureau of Jail Management and Penology
- e. Barangays officials and tanods on duty
- f. Those persons involved in emergency medical cases
- g. Those involved in the delivery of basic necessities like food and medicines
- h. Drivers and helpers of delivery trucks when loading and unloading fruits, vegetables and agricultural products e.g. live hogs, cattle, broilers, eggs and the like
- i. Funeral parlors when retrieving/servicing cadavers
- j. Priests and religious personnel administering religious rites at night
- Street sweepers, garbage collectors, slaughterhouse workers on night shift duty and meat delivery personnel
- Those involved in public transport services (tricycles and the like) in order to ferry/transport goods and conveyances mentioned herein and as determined by the Public Safety and Security Office
- m. Family members up to first degree of consanguinity of the deceased during wakes

**SECTION 4. Enforcement/Implementation.** This ordinance shall be implemented by the Tuguegarao City Police Force, Barangay Chairs and their personnel, Public Safety and Security Office and other personnel as deputized by the Local Chief Executive;

**SECTION 5.** Abuse in the Implementation. In case of abuse in the enforcement of this ordinance, the police, barangay and other deputized personnel shall be subject to disciplinary action under existing laws;

SECTION 6. Penalty. For violation of this ordinance, the following penalties shall be imposed:

First Offense: A fine of Two Thousand Pesos (P2,000.00) Second Offense: A fine of Three Thousand Pesos (P3,000.00)

Third Offense: A fine of Five Thousand Pesos (P5,000,00) and/or 30 days of

imprisonment upon the discretion of the court

SECTION 7. Task Force. To effectively implement the provisions of this ordinance, a Task Force composed of the following is hereby created;

- a. The City Mayor as head or his assigned representative
- b. The City Vice Mayor
- c. The Chief of Police, PNP, Tuguegarao City
- d. 49 Barangay Chairs
- e. The Chair of the Public Safety and Order and Disaster Preparedness of the Sanggunian and all Members of the Eighth City Council
- f. The SK Federation President

**SECTION 8.** Separability Clause. If any part or provision of this ordinance shall be held to be unconstitutional or invalid, other parts or provisions hereof which are not affected thereby shall remain in full force and effect.



**SECTION 9. Repealing Clause**. All ordinances and administrative regulations or part/s thereof which are inconsistent with any provisions of this ordinance are hereby repealed, amended or modified accordingly.

**SECTION 10. Effectivity Clause.** This ordinance shall immediately take effect upon approval and shall remain so until the lifting of the Modified General Community Quarantine.

- 4. CITY ORDINANCE NO. 54-08-2020 "ORDINANCE RECLASSIFYING FROM AGRICULTURAL ZONE TO INDUSTRIAL ZONE OF LOT NO. 2333-A, PSD-372237 BEING A PORTION OF LOT NO. 2333 OF TCT NO. 032-2016004421 COVERING AN AREA OF 3,348 SQUARE METERS LOCATED AT BUNTUN, TUGUEGARAO CITY".
