#### CITY ORDINANCE NO. 52-08-2020

AN ORDINANCE CONDONING ALL PENALTIES, SURCHARGES, INTERESTS AND OTHER FEES FOR THE LATE PAYMENT OF REAL PROPERTY TAX, BUSINESS TAX AND RENTALS OF STALLS AT THE TUGUEGARAO CITY COMMERCIAL CENTER AND PEOPLE'S GYMNASIUM FROM MARCH 20, 2020 UNTIL DECEMBER 31, 2020

WHEREAS, the World Health Organization (WHO) declared on March 12, 2020 that COVID-19 has become a "pandemic";

WHEREAS, President Rodrigo Roa Duterte has issued Executive Order No. 922 declaring a State of Public Health Emergency due to novel corona virus disease (COVID-19) and subsequently ordered for the Enhanced Community Quarantine (ECQ) of the entire Luzon;

WHEREAS, on March 16, 2020, President Rodrigo Roa Duterte declared a state of calamity in the Philippines for six months through Proclamation No. 929 as cases of the novel coronavirus in the country has continued to rise;

WHEREAS, on March 23, 2020, President Rodrigo Roa Duterte signed Republic Act No. 11469, otherwise known as "Bayanihan to Heal as One Act," An Act Declaring the Existence of a National Emergency arising from the Coronavirus Disease;

WHEREAS, in order to ease the burden of the affected constituents, the City Mayor, Hon. Atty. Jefferson, has requested the Eighth City Council for the enactment of an ordinance condoning all penalties, surcharges, interests and other fees for the late payment of Real Property Tax, Business Tax and Rentals of stalls at the Tuguegarao City Commercial Center (TCCC) and People's Gymnasium from March 20, 2020 until December 31, 2020;

WHEREAS, the Eighth City Council during its Regular Session held on August 11, 2020 deemed it proper, necessary and urgent to approve the herein request being beneficial to the concerned constituents of the City.

**NOW**, **THEREFORE**, be it **ORDAINED**, as it is hereby **ORDAINED**, by the Eighth City Council in Tuguegarao City, in session duly assembled to enact the following:

**Section 1. Title**. This Ordinance shall be referred to as An Ordinance Condoning All Penalties, Surcharges, Interests and other fees for the late payment of Real Property Tax, Business Tax and Rentals of stalls at the Tuguegarao City Commercial Center and People's Gymnasium from March 20, 2020 until December 31, 2020.

**Section 2. Declaration of Policy.** Paragraph z, Section 4 of Republic Act No. 11469, otherwise known as "Bayanihan to Heal as One Act," states that "move statutory deadlines and times for the filing and submission of any document, the payment of taxes, fees, and other charges required by law, and the grant of any benefit, in order to ease the burden on individuals under Community Quarantine";

Section 3. Subject of Condonation. This Ordinance shall condone all penalties, surcharges, interests and other fees for the late payment of Real Property Tax, Business Tax and Rentals of stalls at the Tuguegarao City Commercial Center and People's Gymnasium.

**Section 4. Period of Condonation.** The condonation shall be applicable from March 20, 2020 until December 31, 2020 only.

Section 5. Separability Clause. The provisions of this ordinance are hereby declared to be separable; in the event that one or more of the provisions are held illegal or unconstitutional, the validity of the other provisions shall not be affected.

**Section 6. Effectivity**. This Ordinance shall take effect upon its approval and in accordance with the provisions of the Local Government Code.
