
Madam:

CITY ORDINANCE NO. 74-08-2020

**AN ORDINANCE AMENDING SECTION 2 OF CITY ORDINANCE NO. 45-08-2020
 EXPANDING THE OPERATION OF TRICYCLES DURING THE PERIOD OF MODIFIED
 GENERAL COMMUNITY QUARANTINE (MGCQ) IN TUGUEGARAO CITY AND
 SUSPENDING FOR THE MEANTIME THE EXISTING FARE MATRIX IN
 CITY ORDINANCE NO. 21-2018**

WHEREAS, the Province of Cagayan including Tuguegarao City was placed under Modified General Community Quarantine (MGCQ) on July 1, 2020;

WHEREAS, the MGCQ is defined by the Inter-Agency Task Force as “the transition phase between General Community Quarantine (GCQ) and New Normal, when the following temporary measures are relaxed and become less necessary: limiting movement and transportation, the regulation of operating industries and the presence of uniformed personnel to enforce community quarantine protocols;”

WHEREAS, Tuguegarao City was reverted to Modified Enhanced Community Quarantine (MECQ) from October 03, 2020 until October 16, 2020 due to the alarming increase of COVID-19 cases;

WHEREAS, on October 17, 2020, Tuguegarao City shall be placed under MGCQ again;

WHEREAS, a Consultative Meeting was held by the Tuguegarao City Government on October 12, 2020 at the City Hall Lobby, Carig Sur, Tuguegarao City with the Tricycle Operators and Drivers Association (TODA) Presidents, Officers and Members who, at their own initiative, proposed the herein new operation scheme;

WHEREAS, the Federation President requested, too, the City Mayor, Hon. Atty. Jefferson P. Soriano, through a letter dated September 12, 2020 proposing for a new scheme;

WHEREAS, the City Mayor, Hon. Atty. Jefferson P. Soriano, has indorsed the letter to the Eighth City Council for consideration;

WHEREAS, the Eighth City Council during its 60th Regular Session held on October 13, 2020 deemed it proper, necessary and beneficial to approve the herein indorsement.

NOW, THEREFORE, for and in consideration of the foregoing premises, the Body hereby **RESOLVES**, to adopt the following City Ordinance:

Section 1. Title. This Ordinance shall be known as “**AN ORDINANCE AMENDING SECTION 2 OF CITY ORDINANCE NO. 45-08-2020 EXPANDING THE OPERATION OF TRICYCLES DURING THE PERIOD OF MODIFIED GENERAL COMMUNITY QUARANTINE (MGCQ) IN TUGUEGARAO CITY AND SUSPENDING FOR THE MEANTIME THE EXISTING FARE MATRIX IN CITY ORDINANCE NO. 21-2018.**”

Section 2. New Scheme. Section 2 on New Scheme shall be amended as follows:

- A. Tricycles with Plate Numbers ending in 1-4 shall operate during Mondays and Tuesdays;
- B. Tricycles with Plate Numbers ending in 5-7 shall operate during Wednesdays and Thursdays
- C. Tricycles with Plate Numbers ending in 8-0 shall operate during Fridays, Saturdays and Sundays.


Section 3. Separability Clause. If any part or provision of this Ordinance shall be held to be unconstitutional or invalid, other parts or provisions hereof which are not affected thereby shall remain in full force and effect.

Section 4. Public Hearing. This ordinance is enacted under unusual and extreme condition the country is experiencing in general and Tuguegarao City in particular as declared by the National Government through a number of proclamation orders and other rules and regulations promulgated by His Excellency President Rodrigo Duterte and the Provincial Government, hence, the public hearing shall be dispensed with, considering further the urgency and importance of the instant measure.

Section 5. Effectivity. This Ordinance shall be in full force and effect starting on October 17, 2020 and for the entire duration of the Modified General Community Quarantine.
