CITY ORDINANCE NO. 78-08-2020

AN ORDINANCE AMENDING SECTIONS 4 AND 5 (c) OF CITY ORDINANCE NO. 45-08-2020 EXPANDING THE OPERATION OF TRICYCLES DURING THE PERIOD OF MODIFIED GENERAL COMMUNITY QUARANTINE (MGCQ) IN TUGUEGARAO CITY AND SUSPENDING FOR THE MEANTIME THE EXISTING FARE MATRIX IN CITY ORDINANCE NO. 21-2018

WHEREAS, Tuguegarao City is currently under Modified General Community Quarantine (MGCQ);

WHEREAS, the Eighth City Council approved City Ordinance No. 45-08-2020 titled “*An Ordinance Expanding the Operation of Tricycles During the Period of Modified General Community Quarantine (MGCQ) in Tuguegarao City and Suspending for the Meantime the Existing Fare Matrix in City Ordinance No. 21-2018;*”

WHEREAS, the Federation of Tricycle Operators and Drivers Association (FETODA) requested the City Mayor, Hon. Atty. Jefferson P. Soriano, to allow them to convey two (2) passengers provided that rear portion of the driver must place an acetate or plastic cover to serve as barrier through a letter dated October 26, 2020;

WHEREAS, the City Mayor, Hon. Atty. Jefferson P. Soriano, has endorsed the said letter to the Eighth City Council for reference and action;

WHEREAS, the Eighth City Council deemed it necessary to approve the request considering the financial instability of tricycle drivers due to limited days of operation;

WHEREAS, it is strictly required for tricycle drivers to observe health protocols and to provide a barrier between them and passengers.

NOW, THEREFORE, for and in consideration of the foregoing premises, the Body hereby **RESOLVES**, to adopt the following City Ordinance:

Section 1. Title. This Ordinance shall be known as “*AN ORDINANCE AMENDING SECTIONS 4 AND 5 (c) OF CITY ORDINANCE NO. 45-08-2020 EXPANDING THE OPERATION OF TRICYCLES DURING THE PERIOD OF MODIFIED GENERAL COMMUNITY QUARANTINE (MGCQ) IN TUGUEGARAO CITY AND SUSPENDING FOR THE MEANTIME THE EXISTING FARE MATRIX IN CITY ORDINANCE NO. 21-2018.*”

Section 2. Section 4 on Fare Rates. The fare rates in City Ordinance No. 21-08-2020 titled “*An Ordinance Fixing Fare Rates for Tricycles for Hire Operating Within Tuguegarao City*” shall be suspended for the meantime and, instead, the following fare rates, which shall be displayed inside the tricycle through the assistance of the Tricycle Regulation Unit:

NUMBER OF PASSENGERS	ROUTE	REGULAR FARE
ONE (1)	a. Within Poblacion Centro 1-12, including Ugac Sur and Ugac Norte, and Caritan Centro considered Poblacion	P25.00
	b. Outside Poblacion or after three (3) kilometers	P50.00
	c. After six (6) to seven (7) kilometers	P75.00
TWO (2)	a. Within Poblacion Centro 1-12, including Ugac Sur and Ugac Norte, and Caritan Centro considered Poblacion	P20.00 (per passenger)
	b. Outside Poblacion or after three (3) kilometers	P30.00 (per passenger)
	c. After six (6) to seven (7) kilometers	P40.00 (per passenger)

Notes:

1. *In case of two (2) passengers, one (1) passenger shall stay inside the tricycle while the other one (1) shall stay at the back of the tricycle driver provided there is an acetate or plastic cover to serve as a barrier between the driver and the two (2) passengers.*
2. *If one (1) passenger initially rides and along the way, another passenger rides, the fare shall be divided by the said two (2) passengers.*

Section 3. Section 5, item c on Operational Requirements/Restrictions shall be amended as follows:

- c. Tricycle drivers are strictly prohibited from carrying/conveying more than two (2) passengers; hence, they are allowed to convey two (2) passengers at a time.**


Section 4. Separability Clause. If any part or provision of this Ordinance shall be held to be unconstitutional or invalid, other parts or provisions hereof which are not affected thereby shall remain in full force and effect.

Section 5. Public Hearing. This ordinance is enacted under unusual and extreme condition the country is experiencing in general and Tuguegarao City in particular as declared by the National Government through a number of proclamation orders and other rules and regulations promulgated by His Excellency President Rodrigo Duterte and the Provincial Government, hence, the public hearing shall be dispensed with, considering further the urgency and importance of the instant measure.

Section 6. Effectivity. This Ordinance shall be in full force and effect immediately upon approval and for the entire duration of the Modified General Community Quarantine.

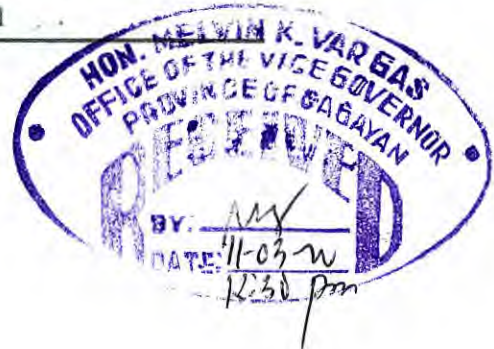


Madam:

Pursuant to Section 54 of the Local Government Code, we are now submitting for review and action the attached legislative measures enacted by the Sangguniang Panlungsod on October 27, 2020 and November 30, 2020 to wit:

- **CITY ORDINANCE NO. 78-08-2020** – An Ordinance Amending Section 4 and 5 (c) of City Ordinance No. 45-08-2020 “Expanding the Operation of Tricycle during the period of Modified General Community Quarantine (MGQC) in Tuguegarao City and Suspending for the meantime the existing Fare Matrix in City Ordinance No. 21-2018
- **CITY ORDINANCE NO. 80-08-2020** – An Ordinance Prohibiting the Use of Karaoke, Videokes and other Similar sound Producing Gadgets that disturb and disrupt Modular and On-line Classes among Homes in the 49 Barangays of Tuguegarao City from Monday to Friday (7:00 AM to 9:00 PM) and Saturday (7:00 AM to 5:00 PM), and Providing Penalties for Violations thereof
- **CITY ORDINANCE NO. 81-08-2020** – An Ordinance Further Amending Section 2 of City Ordinance No. 75-08-2020 Imposing New Curfew Hours during this period of National Emergency in Tuguegarao City Pursuant to Executive Order No. 118-2020
