CITY ORDINANCE NO. 84-08-2020

AN ORDINANCE SUSPENDING SECTION 5 OF CITY ORDINANCE NO. 76-08-2020 SETTING HEALTH PARAMETERS FOR THE ENTRY OF PERSONS TO INCLUDE PERSONS BRINGING HUMANITARIAN AID AND/OR SERVICES AND MEDIA PRACTITIONERS DURING THE STATE OF CALAMITY IN TUGUEGARAO CITY

WHEREAS, Tuguegarao City is under a STATE OF CALAMITY due to the recent massive flooding from November 13-15, 2020;

WHEREAS, several persons representing various entities, government as well as non-government offices, and civil society groups are bringing in humanitarian support and assistance either in the form of foods or services;

WHEREAS, media personnel mostly from Manila are also coming to cover activities or events in the City;

WHEREAS, Tuguegarao City has a standard set of health protocols provided for under City Ordinance No. 76-08-2020 due to the current CORONA VIRUS DISEAS 2019 (COVID-19) especially those coming from Metro Manila and CALABARZON areas;

WHEREAS, a MODIFIED HEALTH PROTOCOL is necessary to facilitate the entry of such persons and entities;

NOW, THEREFORE, be it **ORDAINED** by the Eight City Council in session duly assembled:

SECTION 1. TITLE. This ordinance shall be known as "AN ORDINANCE SUSPENDING SECTION 5 OF CITY ORDINANCE NO. 76-08-2020 SETTING HEALTH PARAMETERS FOR THE ENTRY OF PERSONS *TO INCLUDE PERSONS BRINGING HUMANITARIAN AID AND/OR SERVICES AND MEDIA PRACTITIONERS DURING THE STATE OF CALAMITY IN TUGUEGARAO CITY.*"

SECTION 2. Section 5 of City Ordinance No. 76-08-2020 shall be suspended to include persons bringing humanitarian aid and/or support and all MEDIA practitioners covering news events in Tuguegarao City during this State of Calamity.

MODIFIED HEALTH PROTOCOLS. The following protocols must be observed:

1. These persons shall first register on-line or call the following numbers:

- a. +639168872897;
- b. +639563747979; and
- c. +639563477981,

providing therein their personal circumstances, their purpose in coming to Tuguegarao City, the hotel/hostel or lodging house or inn where they will be staying, the duration/period of their stay in the City, contact numbers and other relevant information.

2. They shall strictly observe the following minimum health protocols:

- a. Wearing of face mask and face shield;
- b. Social distancing;
- c. Bringing along with them alcohol or disinfectants for constant cleansing of hands;
- d. Having their body temperature checked at all times whenever possible; and
- e. Immediately reporting to health authorities any signs or symptoms related to COVID-19


SECTION 3. IMPEMETING RULES AND REGULATIONS. The Office of the City Mayor shall formulate the Implementing Rules and Regulations of this ordinance.

SECTION 4. VIOLATION. Any violation of this ordinance shall cause the discontinuation of the services and/or operations of the subject individuals.


SECTION 5. EFFECTIVITY. This Ordinance shall take effect immediately, and shall be in force and effect until repealed.


