CITY ORDINANCE NO. 85-08-2020

**AN ORDINANCE AMENDING CITY ORDINANCE NO. 81-08-2020
IMPOSING NEW CURFEW HOURS FROM 12 MIDNIGHT TO 3 AM
STARTING DECEMBER 16, 2020 UNTIL DECEMBER 31, 2020**

WHEREAS, Section 16 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, states that *“the Local Government Units are authorized to exercise powers necessary, appropriate or incidental for their efficient and effective governance and those which are essential to the promotion of the general welfare”*;

WHEREAS, in order to regulate the movement of people, the Eighth City Approved during its Special Session held on October 30, 2020 City Ordinance No. 81-08-2020 titled AN ORDINANCE FURTHER AMENDING SECTION 2 OF CITY ORDINANCE NO. 75-08-2020 IMPOSING NEW CURFEW HOURS DURING THIS PERIOD OF NATIONAL EMERGENCY IN TUGUEGARAO CITY PURSUANT TO EXECUTIVE ORDER NO. 118-2020;

WHEREAS, in the said Ordinance, the new curfew hours, from 12:00 MN to 4:00 AM, was imposed within the territorial jurisdiction of Tuguegarao City starting October 30, 2020.

WHEREAS, in view of the Christmas Season, there is a need to amend the curfew hours to accommodate the traditional early Misa De Gallo.

NOW, THEREFORE, be it **ORDAINED** by the Sangguniang Panlungsod in session assembled, to enact:

Section 1. Curfew. Section 1 on Curfew of Ordinance No. 81-08-2020 is hereby amended to read as follows:

The new curfew hours, from 12:00 MN to 3:00 AM, is hereby imposed within the territorial jurisdiction of Tuguegarao City starting December 16, 2020 until December 31, 2020.

Section 2. Public Hearing. This ordinance is enacted under unusual and extreme condition the country is experiencing in general and Tuguegarao City in particular as declared by the National Government through a number of proclamation orders and other rules and regulations promulgated by His Excellency President

Rodrigo Duterte and the Provincial Government, hence, the public hearing shall be dispensed with, considering further the urgency and importance of the instant measure.


Section 3. Enforcement/Implementation. This ordinance shall be implemented by the Tuguegarao City Police Force, Barangay Chairs and their personnel, Public Safety and Security Office and other personnel as deputized by the Local Chief Executive.

Section 4. Repealing Clause. All prior issuances or parts thereof inconsistent with this Ordinance are hereby repealed, amended or otherwise modified accordingly.


Section 5. Effectivity. This Ordinance shall take effect starting December 16, 2020 until December 31, 2020.
