CITY ORDINANCE NO. 94-08-2020

AN ORDINANCE SUSPENDING SECTION 6, PARAGRAPHS A AND C, SECTION 7 AND SECTION 8, FIRST PARAGRAPH, OF CITY ORDINANCE NO. 41-2017 AND SECTION 3 OF CITY ORDINANCE NO. 66-2017 AND TO ADOPT RULES AND REGULATIONS ON THE SALE, USE AND DISTRIBUTION OF FIRECRACKERS, PYROTECHNIC DEVICES AND OTHER SIMILAR EXPLOSIVES FROM DECEMBER 26, 2020 TO NOON OF JANUARY 01, 2021"

WHEREAS, Republic Act No. 7183, otherwise known as "*An Act Regulating the Sale, Manufacture, Distribution and Use of Firecrackers and other Pyrotechnic Devices,*" aims to regulate and control the manufacture, sale, distribution and use of firecrackers and other pyrotechnic devices consistent with, and in furtherance of, public safety, order and national security;

WHEREAS, Joint Memorandum Circular No. 1 series of 2016 was issued to enjoin the coordinative efforts of the Department of the Interior and Local Government, Philippine National Police, Bureau of Fire Protection, Department of Health, Department of Trade and Industry, Department of Finance, Bureau of Customs and Local Government Units to strictly implement the provisions of R.A No. 7183;

WHEREAS, Section 16 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, mandates all LGUs to promote peace and order and public safety in order to secure the comfort of the people in their respective jurisdictions;

WHEREAS, the Seventh City Council approved on September 12, 2017 City Ordinance No. 41-2017 "An Ordinance Regulating the Sale, Distribution, Possession and Use of Firecrackers, Pyrotechnic Devices and other Similar Explosives within the Territorial Jurisdiction of Tuguegarao City";

WHEREAS, An Ordinance Amending Sections 3 and 8 of City Ordinance No. 41-2017 was enacted by the Seventh City Council on December 12, 2017.

WHEREAS, the City Mayor, Hon. Atty. Jefferson P. Soriano, indorsed to the Eighth City Council his request for suspension of some of the provisions of the abovementioned ordinances pertaining to the sale, distribution, possession and use of firecrackers, pyrotechnic devices and other similar explosives within the territorial jurisdiction of Tuguegarao City in view of the threats of the Covid-19 virus.

WHEREFORE, The Eighth City Council in session duly assembled, hereby ordains:

Section 1. The implementation of Section 6, paragraphs a and c, Section 7 and Section 8, first paragraph, of City Ordinance No. 41-2017 and Section 3 of City Ordinance No. 66-2017 is hereby suspended.

Section 2. The sale, use and distribution of firecrackers and other pyrotechnic devices shall be authorized subject to the following rules and regulations:

A. Display and sale of firecrackers and other pyrotechnic devices shall be conducted on December 26 to December 31, 2020 only from 8AM to 8PM except December 31, 2020 from 8AM to 11PM.

B. The venue for the display and sale of the same shall be at the corner of Pagulayan Street, Centro 11 (Balzain East) and Balao Street up to the corner of Macapagal Avenue.

C. The use of firecrackers and other pyrotechnic devices shall be allowed only on December 30 and December 31, 2020.

D. The distribution of stalls shall be by lottery.

E. The POSSU Head shall submit a Proposed Traffic Plan, Route Plan, number of stalls and distances thereat in order to observe physical distancing.

F. Stall owners, vendors and vendees shall observe and comply with City Ordinance No. 89-08-2020 *"An Ordinance Amending Section 9 of City Ordinance No. 61-08-2020 ". Mandating the Wearing of Protective Face Mask and Face Shields in Tuguegarao CIO, and Providing Penalties for Violations Thereof"*

Section 3. All other provisions of City Ordinance No. 41-2017 and City Ordinance No. 66-2017 shall remain in full force and effect.


Section 4. IMPLEMENTING RULES AND REGULATIONS. The Implementing Rules and Regulations shall be adopted by the Local Chief Executive for the smooth and effective implementation of this ordinance.

Section 5. PUBLIC HEARING. This ordinance is enacted under unusual and extreme condition the country is experiencing in general and Tuguegarao City in particular as declared by the National Page 1 of 2 Government through a number of proclamation orders and other rules and regulations promulgated by His Excellency President Rodrigo Duterte and the Provincial Government, hence, the public hearing shall be dispensed with, considering further the urgency and importance of the instant measure.

Section 6. EFFECTIVITY CLAUSE. This Ordinance shall take effect on December 26, 2020 until noon of January 01, 2021.
