A RESOLUTION ADOPTING AND APPROVING LOCAL COUNCIL FOR THE PROTECTION OF CHILDREN (LCPC) RESOLUTION NO. 1-2019 TITLED “RESOLUTION APPROVING THE COMPREHENSIVE LOCAL JUVENILE INTERVENTION PROGRAM (CLJIP) 2019-2022”

WHEREAS, the referral “Indorsement of the City Mayor, Hon. Atty. Jefferson P. Soriano, on Local Council for the Protection of Children (LCPC) Resolution No. 01-2019 titled “Resolution Approving the Comprehensive Local Juvenile Intervention Program (CLJIP) 2019-2022” was endorsed to the Eighth City Council;

WHEREAS, the Joint Committee on Rules, Laws and Ethics and Committee on Youth and Sports Development to which the matter was referred, met on January 06, 2020 to discuss the subject referral;

WHEREAS, the Seventh City Council in its 53rd Regular Session held on August 29, 2017 approved City Ordinance No. 32-2017 titled “An Ordinance Establishing Local Juvenile Intervention and Diversion Programs, Pursuant to the Provisions of Juvenile Justice and Welfare Act of 2006 (RA 9344), Providing Funds Therefore and for Other Purposes”;

WHEREAS, the Local Council for the Protection of Children enacted Council Resolution No. 01-2019 titled “Resolution Approving the Comprehensive Local Juvenile Intervention Program (CLJIP) 2019-2022”;

WHEREAS, the Resolution is pursuant to Section 13, Article II of the 1987 Constitution and Republic Act No. 9344, otherwise known as the Juvenile Justice and Welfare Act of 2006 as amended by Republic Act No. 10630, an Act Strengthening the Juvenile Justice System;

WHEREAS, it is a 3-year program formulated to cater services in delinquency prevention up to rehabilitation;

WHEREAS, reintegration of programs and activities on Child-at-Risk and Children-in-Conflict with the law is also provided;




WHEREAS, upon review of the subject referral, the joint Committees recommend for the approval of Local Council Resolution No. 01-2019.
