WHEREAS, the United Nations Convention on the Rights of the Child (UNCRC) for which the Philippine is a signatory provides participation rights to children that encompass children’s freedom to express opinions, to have a say in matters affecting their own lives, to join associations and assemble peacefully and as their capabilities develop, should have an increasing opportunity to participate in the activities of the society in preparation for adulthood;

WHEREAS, it is a declared policy of the state and the Tuguegarao City Government to give utmost priority to the rights of children for survival, protection, participation and development of their potentials;

WHEREAS, children must be afforded the necessary protection and assistance to be able to undertake their responsibilities within the community, being the next leaders and stewards of our society;

WHEREAS, pursuant thereto and in its effort to protect and promote the general welfare of children who are the most vulnerable sector of the society, the Tuguegarao City Development Council approved CDC Resolution No. 16-2019 titled "*Resolution for the Inclusion of a Child Representative as a Member of the City Development Council of Tuguegarao City*;"

WHEREAS, the Child Representative to the City Development Council will strengthen the active participation and involvement of children in development planning and the effective implementation of the city's programs, projects and activities;

WHEREAS, the City Mayor, Hon. Atty. Jefferson P. Soriano, has endorsed to the Eighth City Council CDC Resolution No. 16-2019 for adoption;

WHEREAS, by virtue of the adoption of Committee Report No. 006-2020, the Eighth City Council during their 27th Regular Session deemed it proper, necessary and beneficial to adopt the said indorsement.

WHEREAS, the Two Million Pesos (P2,000,000.00) funding has already been incorporated in the Executive Annual Budget for CY 2020;




On joint motion, **CITY RESOLUTION NO. 019-08-2020** was **APPROVED** under suspended rules.
