RESOLUTION GRANTING PROVISIONARY PERMIT TO PARTAS TRANSPORTATION COMPANY, INC. TO CONSTRUCT A TERMINAL-GARAGE IN DIVERSION ROAD, BARANGAY SAN GABRIEL (BARANGAY PALLUA), TUGUEGARAO CITY

WHEREAS, the Tuguegarao City, being a regional center in education, trade and industry, has a high demand for the transportation needs of the people, hence, the Tuguegarao City Government recognizes the crucial role of the transportation group that caters to needs of the riding public;

WHEREAS, Partas Transportation Company, Inc., represented by its President, Mr. Romel V. Singson, manifested their intent to construct a terminal-garage with a lot of 4,783 square meters at Barangay San Gabriel (Pallua), Tuguegarao City, the same of which has been indorsed by the City Mayor, Hon. Atty. Jefferson P. Soriano, to the Eighth City Council;

WHEREAS, Partas Transportation Company, Inc. has submitted the documentary and administrative requirements as prescribed by the Land Transportation Franchising and Regulatory Board (LTFRB) and City Ordinance No. 25-2019 titled “*An Ordinance Regulating the Establishment, Operation and Maintenance of Public/Private Transport Terminals Within the Territorial Jurisdiction of Tuguegarao City, Cagayan and Providing Funds Thereof*” and other issuances in connection thereto;

WHEREAS, the Technical Working Group has identified the lacking documentary/administrative requirements for which the applicant shall execute an Affidavit of Undertaking within five (5) days from

receipt of the Resolution to comply with the said lacking administrative and documentary requirements within the period of six (6) months, to wit:

1. Site Development Plan and Design of the proposed public transport terminal showing compliance to the requirements and standards prescribed in City Ordinance No. 25-2019.
2. Certified True Copy of Land Title, Tax Declaration or any evidence of ownership.
3. A fleet operations management guide or manual which provides among others the procedures or methods of dispatching, safety and security guides or plans, and other requirements necessary in the operation of private/public transport terminals; and other requirements stipulated in City Ordinance No. 25-2019.
4. Requirements under Section 7 of City Ordinance No. 25-2019.

WHEREAS, the aforementioned area would help provide a suitable and convenient pick-up station which will decongest traffic in the city;

WHEREAS, after the presentation and adoption of the committee report, the Eighth City Council during their 28th Regular Session held on January 28, 2020, deemed it proper and necessary to approve the herein resolution since the same will be beneficial not only to the constituents of the city but also to the general public.



CITY RESOLUTION NO. 024-08-2020

RESOLUTION APPROVING THE REQUEST FOR A NEW BIGGER OFFICE OF BARANGAY CENTRO 07 LOCATED AT THE 3rd FLOOR (BESIDE TRAFFIC MANAGEMENT GROUP OFFICE), TUGUEGARAO CITY COMMERCIAL CENTER, CENTRO 07, TUGUEGARAO CITY

WHEREAS, the Barangay Council of Centro 07 passed Resolution No. 05, series of 2019 “Resolution Requesting Honorable Mayor Jefferson P. Soriano for a New Bigger office of Barangay Centro 07, Tuguegarao City, located at the 3rd Floor (Beside TMG Office) Tuguegarao City Commercial Center, Centro 07, Tuguegarao City;”

WHEREAS, as stated in the Barangay Resolution of Centro 07, their existing office has a very small space which cannot accommodate large crowd especially during meetings and assemblies and also their need for a bigger space to put all the properties owned by the barangay;

WHEREAS, the City Mayor, Hon. Atty. Jefferson P. Soriano, has endorsed to the Eighth City Council the said Barangay Resolution of Centro 07;

WHEREAS, the Committee on Agriculture and Food, Market and Livestock Auction Center and Committee on Barangay Affairs to which the matter was referred, met on January 13, 2020 to discuss the subject referral with the presence of resource persons;

WHEREAS, according to the Market Administrator, Mr. Pedro Cuntapay, the vacant office space has an area of 98 square meters (9.7 x 10.7 meters), located at the 3rd Floor (beside TMG Office, fronting Bonifacio Street), Tuguegarao City Commercial Center, Tuguegarao City;

WHEREAS, the said new vacant office space for Barangay Centro 07 is for free;

WHEREAS, after the deliberation in the committee meeting held for the said purpose, the Joint Committees found the request to be in order, with merit and beneficial to the constituents of Tuguegarao City particularly the constituents of Barangay Centro 07;

WHEREAS, the committees approved the request subject to the following conditions:


- a. To vacate their existing office located at the ground floor of the Tuguegarao City Commercial Center as soon as the new office is available for occupancy;
- b. Any improvement of the new office/building shall be solely shouldered by the barangay and that the building plan shall be subject to the approval of the City Engineering Office; and,
- c. The monthly electrical and water bills shall be borne by the barangay.

NOW, THEREFORE, RESOLVE, as it is hereby **RESOLVED**, to approve the request for a new bigger office of Barangay Centro 07 located at the 3rd Floor (beside Traffic Management Group Office), Tuguegarao City Commercial Center, Centro 07, Tuguegarao City.


