CITY RESOLUTION NO. 025-08-2020

A RESOLUTION REQUIRING ALL PUBLIC AND PRIVATE SCHOOLS, COLLEGES, UNIVERSITIES AND VOCATIONAL SCHOOLS IN ALL LEVELS INCLUDING ALL GOVERNMENT ENTITIES, NON-GOVERNMENT OFFICES, MEDIA OF ALL FORMS AND PRIVATE ESTABLISHMENTS WITHIN THE CITY OF TUGUEGARAO TO CONDUCT A MASSIVE INFORMATION DISSEMINATION DRIVE REGARDING THE DEADLY NOVEL CORONA VIRUS TO BE SPEARHEADED BY THE DEPARTMENT OF HEALTH AND CITY HEALTH OFFICE

WHEREAS, the 2019 Novel Corona Virus (2019-NCoV) is a virus (more specifically, a coronavirus) identified as the cause of an outbreak of respiratory illness first detected in Wuhan, China. Early on, many of the patients in the outbreak in Wuhan, China reportedly had some link to a large seafood and animal market, suggesting animal-to-person spread. However, a growing number of patients reportedly who have no exposure to animal markets indicating person-to-person spread is occurring worldwide;

WHEREAS, to date, according to the World Health Organization, China death toll from this deadly virus rises to 213 and with confirmed cases that increased to 9,692. Meanwhile, on January 30, 2020, the Department of Health confirmed the first 2019 Novel Corona Virus case in the Philippines, a 38-year old woman who travelled to the Philippines from Wuhan, China;

WHEREAS, in Nueva Vizcaya, two persons were reportedly under medical observation due to signs and symptoms related to the 2019 Novel Corona Virus;

WHEREAS, the City Government of Tuguegarao should establish a contingency plan regarding preventive measures people should do in case signs and symptoms of the deadly corona virus are experienced;

WHEREAS, a multi-sectoral approach be done as far as information dissemination is concerned, in order to disseminate prompt and accurate information to the public and to avoid fake news from the government and agencies concerned;

WHEREAS, Cagayan Valley Medical Center (CVMC) being the Regional Hospital should be equipped with the needed facility with hospital isolation room to accommodate suspected carrier for close medical monitoring;

WHEREAS, all school clinics both private and public in Tuguegarao City are advised to check and monitor temperatures of students, identify signs and symptoms related to NCoV and bring identified suspected victims or persons under investigation immediately to the CVMC while simultaneously informing parents and Barangay;

WHEREAS, a monitoring board in Tuguegarao City should be established spearheaded by the City Health Office in all schools, in all levels, all barangays and establishments in the entire Tuguegarao City to prevent the unprecedented spread of virus should there be identified cases and provide the Office of the City Mayor and Office of the City Vice Mayor for necessary contingency measures therein.

NOW, THEREFORE, RESOLVE, as it is hereby RESOLVED, to require all public and private schools, colleges, universities and vocational schools in all levels including all government entities, non-government offices, media of all forms and private establishments within the City of Tuguegarao to conduct a massive information dissemination drive regarding the deadly novel corona virus to be spearheaded by the Department of Health and City Health Office.

RESOLVED FURTHER, to furnish a copy of this Resolution to the Department of Education, Department of Health, 49 Barangays, People's Emergency Hospital, Cagayan Valley Medical Center and all concerned as enumerated in this resolution for their information.

On joint motion, CITY RESOLUTION NO. 025-08-2020 was APPROVED under suspended rules.
