 OF THE IMPLEMENTING RULES AND REGULATIONS OF THE
 LOCAL GOVERNMENT CODE AND DILG MC NO. 2019-72**

WHEREAS, the Department of Interior and Local Government (DILG) issued Memorandum Circular (MC) 2019-72 - *Accreditation of Civil Society Organizations, and Selection of Representatives to the Local Special Bodies* dated May 22, 2019;

WHEREAS, the said Memorandum Circular reiterates the provisions of the Local Government Code relative to the accreditation of civil society organizations, and in the selection of representatives to the local special bodies to strengthen their participation in local governance and development processes;

WHEREAS, the Sangguniang Panlungsod of Tuguegarao City recognizes the vital role of Civil Society Organizations (CSOs) which include non-state and non-profit associations, non-governmental organizations, people's organizations, civil organizations, cooperatives, social movements, and professional and business groups in nation building and their collective efforts towards progress;

WHEREAS, the Sangguniang Panlungsod of Tuguegarao City further recognizes the role of the CSOs as partners of the Tuguegarao City Government not only in policy and planning formulation but more so in development implementation;

WHEREAS, the Sangguniang Panlungsod of Tuguegarao City through the Committee on Rules, Laws and Ethics has reviewed and approved the application for accreditation of the Philippine Guardians Brotherhood Incorporated (PGBI) Mabuhay Chapter;

WHEREAS, the accreditation shall be valid for three (3) years commencing on February 03, 2020 up to June 2022;




