RESOLUTION APPROVING THE DEED OF DONATION MADE AND ENTERED INTO BY AND BETWEEN THE PHILIPPINE CHARITY SWEEPSTAKES OFFICE (PCSO) AND TUGUEGARAO CITY GOVERNMENT FOR A PATIENT TRANSPORT VEHICLE (PTV) AND GRANTING AUTHORITY TO THE CITY MAYOR, HON. ATTY. JEFFERSON P. SORIANO, TO SIGN FOR AND ON BEHALF OF THE TUGUEGARAO CITY GOVERNMENT THE SAID DEED OF DONATION

WHEREAS, the Philippine Charity Sweepstakes Office (PCSO) is a government controlled corporation whose mandate is to raise and provide funds for health programs, medical assistance and services consistent with the thrust of the present administration in ensuring that medical facilities are readily available for emergency purposes;

WHEREAS, the Eighth City Council approved City Resolution No. 030-08-2020 titled “Resolution Requesting the Philippine Charity Sweepstakes Office (PCSO) for a Patient Transport Vehicle (PTV) to be Used in Tuguegarao City” during its Special Session held on February 14, 2020;

WHEREAS, the PCSO shall be donating a PTV in connection with the PCSO Medical Transport Vehicle Donation Program;

WHEREAS, after a deliberation on the matter, the Eighth City Council during its Special Session deemed it proper and urgent to approve the herein resolution since it is beneficial to the constituents of the City.


NOW, THEREFORE, RESOLVE, as it is hereby **RESOLVED**, to approve the Deed of Donation made and entered into by and between the Philippine Charity Sweepstakes Office (PCSO) and Tuguegarao City Government for a Patient Transport Vehicle (PTV) and granting authority to the City Mayor, Hon. Atty. Jefferson P. Soriano, to sign for and on behalf the Tuguegarao City Government the said Deed of Donation.
