**CITY RESOLUTION NO. 057-08-2020**

**RESOLUTION APPROVING THE ACKNOWLEDGMENT OF CALAMITY ASSISTANCE FROM THE PHILIPPINE CHARITY SWEEPSTAKES OFFICE (PCSO) WITH UNDERTAKING AND GRANTING AUTHORITY TO THE CITY MAYOR, HON. ATTY. JEFFERSON P. SORIANO, TO SIGN FOR AND ON BEHALF OF THE TUGUEGARAO CITY GOVERNMENT THE SAID ACKNOWLEDGMENT WITH UNDERTAKING**

**WHEREAS**, the referral “*Indorsement of the City Mayor, Hon. Atty. Jefferson P. Soriano, requesting for an authority to sign for and on behalf the Tuguegarao City Government the Acknowledgment of Calamity Assistance from the Philippine Charity Sweepstakes Office (PCSO) with Undertaking*” was indorsed to the Eighth City Council;

**WHEREAS**, the Committee on Rules, Laws and Ethics to which the matter was referred, met on February 13, 2020 to discuss the subject referral with the presence of resource persons;

**WHEREAS**, the Tuguegarao City Government is one of the beneficiaries under the Calamity Assistance Program under the Philippine Charity Sweepstakes Office;

**WHEREAS**, LGU Tuguegarao City will receive a calamity assistance in the amount of One Million Five Hundred Thousand Pesos (P1,500,000.00);

**WHEREAS**, the calamity assistance shall be used for the following:

1. The food needs of and feeding projects for displaced families in evacuation centers and/or temporary shelters;
2. Purchase of various medicines and/or medical supplies necessary for the conduct of health-related activities for disease prevention and/or treatment among the affected population including water and hygiene/sanitation requirements.




