**CITY RESOLUTION NO. 060-08-2020**

**RESOLUTION AUTHORIZING THE INCUMBENT CITY MAYOR TO SOLICIT AND ACCEPT DONATIONS AND SPONSORSHIPS AND ENTER INTO CONTRACT OF SPONSORSHIP, MEMORANDUM OF AGREEMENT AND/OR CONTRACT OF SERVICE FOR THE 296<sup>th</sup> ANNUAL PATRONAL FIESTA KNOWN AS “AFI FESTIVAL 2020”**

**WHEREAS**, Section 23 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, provides among other things that *“the local chief executive may, upon authority of the Sanggunian, negotiate and secure financial grants or donations in kind, in support of the basic services or facilities enumerated under Section 17 hereof, from local and foreign assistance agencies without necessity of securing clearance or approval therefor from any department agency, or office of the national government or from any higher local government unit;”*

**WHEREAS**, the Tuguegarao City Government will celebrate the 296<sup>th</sup> Tuguegarao City Annual Patronal Fiesta known as the “AFI Festival” 2020 on August 8-16, 2020;

**WHEREAS**, the donations and sponsorships will be of great help to augment the budget of the City for the said celebration of the 296<sup>th</sup> Tuguegarao City Annual Patronal Fiesta “AFI Festival” 2020;

**WHEREAS**, the City Government has been conducting yearly solicitation of sponsorships which is of great help of augmenting the budget of the city in celebration of the different activities for the AFI Festival;

**WHEREAS**, the incumbent City Mayor, Hon. Atty. Jefferson P. Soriano, requested from the Eighth City Council an authority to solicit and accept donations and sponsorships and other forms of assistance;

**WHEREAS**, the Eighth City Council, after a thorough deliberation during its 31<sup>st</sup> Regular Session held on February 18, 2020, found the request to be in order and necessary;

**WHEREAS**, in order to give credit and recognition to the sponsors and donors, a Resolution of Appreciation shall be given them by the Eighth City Council.


